

**Suggested Deed of Gift of Materials to Archive or Library  
From SNCC Legacy Project & Civil Rights Movement Veterans Website**

\_\_\_\_\_ (referred to after this as the "Institution")

Donor agrees to give to Institution the object(s), paper(s), letter(s), memorabilia, photograph(s), and/or other material(s), in various formats and media, described on the attached Addendum (the "Donations"). Donor transfers ownership of the Donations, by way of gift and without limitation or restriction, to the Institution, its successors, and assigns.

Donor may have intellectual property rights in the Donations, including copyrights and moral rights. Donor shall retain ownership of any intellectual property rights in the Donations. To the extent Donor has intellectual property rights in any of the Donations, Donor grants to Institution a perpetual, irrevocable, worldwide, royalty-free, non-exclusive right to copy the Donations, distribute copies of the Donations, prepare works based on the Donations ("derivative works"), and to publicly perform and/or publicly display the Donations.

Donor also grants Institution the right to authorize others to make these uses on the Institution's behalf. Provided that: Donor does not represent that Donor is the owner of any intellectual property in the Donations, and Institution agrees that (1) Institution is not relying on any representation or statement of Donor regarding ownership of or rights in any intellectual property and (2) Institution agrees to hold Donor harmless against any claims concerning intellectual property in the Donations that may arise out of Institution's use of the Donations.

Consistent with applicable law, Donor's rights in the work created under this agreement may be transferred as directed by will or intestate succession unless transferred by the Donor during his or her lifetime.

Donor understands that the Institution will make the Donations available to the public. Part or all of the Donations may be preserved, publicly displayed, quoted from, published, or otherwise made available for research) to the extent and at such times the Institution deems appropriate.

If any of the Donations is an original copy or an original object, the Institution agrees to provide the Donor with a photographic copy of that Donation.
