Highlights of SNCC Meeting, April 21-23, 1961, Johnson C. Smith University, Charlotte, North Carolina

The Student Nonviolent Coordinating Committee closed its busy week-end agenda on a high vote calling for sit-iners across the South to extend their efforts into job discrimination, theater stand-ins, recreational (golf courses, swimming pools, beaches) facilities, and an all out voter registration campaign, entitled "Operation Door Knock".

Also from the meeting came the unaminous decision to telegram a call to President Kennedy and Sargeant Shriver, newly appointed Peace Corps, head, to place Fayette and Haywood Counties in Tennessee on the State Dept. roster for technical assistance when the program is initiated.

The Committee also approved the "School Closing Project" which will be a follow-up drive ef-C by CORE to test the dining facilities in interstate travel. The Committee strongly urged students to send detailed complaints of their being denied service to the Justice Department and to SNCC, who will in turn pressure the I.C.C. and the Justice Dept. to take appropriate action to see that the Supreme Court's decree is implemented.

Among the high points on the Committee's agenda was the stand-in demonstration staged before area theaters. Two members of the Coordinating Committee, Charles Sherrod, of Richmond, Va., and James Hester, of Charlette, N. C., were arrested and placed under a fifty dollar bonds each for alleged trespassing violations.

The Committee decided to put "Operation Door Knock", into operation in Rock Hill, S. C., and Mississippi. The Committee pointed out that it is willing to cooperate and to formulate our resources in getting the program under way. CORE expressed a desire to cooperate jointly with this program. Details have to be worked out accordingly; personnel and funds.

The Committee decided that employment would be their long range program, and that they would for the present, concern themselves with the Telephone Company and that the Bus Companies(local) by placed on the agenda for future consideration. Here also, details were not spelled out. (Negro operators and phone line men)

The Committee requested that all areasbe notified about the importance of May 17th and that they hold some type of demonstration in their community; namely in connection with travel facilities.

The Committee decided to launch an all out fund raising campaign in the immediate future. Still concerned about hiring a Field Secretary in the near future; funds permitting. The Committee decided that a Fall Conference would be held, but tabled discussion of any plans until next meeting; and gave the Administrative Sec'y the authority to do any investigation he felt would add to the proposed Conference taking place.

The Committee also said that "we recognize the ever increasing need to broaden the base of the sit—in efforts and the Coordinating Committee is going on record as willing to participate whole—heartedly with each co-ordinating effort convened in good faith to supply this broader base for massive student nonviolent direct—action".

The next SNCC meeting will be held on the 8,9,10,11 of June, in Louisville, Kentucky.

Mr. Charles McDew presided over the meeting as official Chairman, and Miss Lydia Tucker was asked to serve as recorder. The agenda was adopted as printed.

I. Review Of The February Minutes

Members of the Coordinating Committee received copies of the February minutes and the recommendations were reviewed for any changes or clarifications.

II. SNCC Fall Conference

It was decided by the Committee to table discussion on this matter until the next meeting.

III. Committee Action

The Committee approved the "School Closing Project" presented by the Administrative Secretary and requested that directives be sent to all student protest groups and Colleges asking their participation and cooperation in this campaign. The campaign would call attention to the equal access of all facilities to interstate passengers regardless of race. The Chairman was asked to write a letter to the Federal Bureau of Investigation asking them to be on guard for possible violence throughout various Southern cities during May 21-June 10.

IV. Summer Action Programs

The Committee decided to encourage students to use public Beaches, Parks, Golf Courses, Tennis Courts and Swimming Pools during the summer. Further details as to how this project can be successfully carried out, will be discussed at the June meeting.

It was decided that BNCC should encourage people to register and vote. The Committee also decided to work with Mr. Amzie Moore of Cleveland, Mississippi in getting a Voter Registration Project underway there this summer, and to cooperate with CORE in the same effort in Rock Hill, S. C.

It was further decided by the Committee that we encourage all members of SNCC and other protest groups to register when they become of age in their respective state.

The Voter Registration effort should be called "OPERATION DOOR KNOCK".

V. Future Action Programs

After much discussion, the Committee decided to accept the proposal coming from the Administrative Secretary concerning a Southwide student employment project for the Fall. This effort would be concerned with the employment of Negroes as telephone operators and line-men. The details are to be worked out at the June meeting.

The Committee decided to table discussion on a proposed Fall Bus Company Employment project until the June meeting.

VI. Fayette and Haywood Counties, Tennessee

The Committee decided to telegram President Kennedy and Sargeant Shiver,

head of the Peace Corps., requesting that Fayette and Haywood Counties, Tennessee be placed on the State Department roster for technical assistance when the program is initiated.

VII. National Student Association

The Committee accepted the resignation of Timothy Jenkins, National Affairs Vice-President, USNSA as a member of the Coordinating Committee. Mr. Jenkins stated that he has a organizational technicality and that his status with SNCC would have to be presented to the USNSA Congress for approval.

VIII. Finance Committee

The Committee decided to replace Timothy Jenkins with Charles Jones as a member of the Finance Committee.

IX. SNCC Brochure

The Committee voted to commend the work the Administrative Secretary presented to the meeting concerning the descriptive piece on "This Is SNCC". It was suggested that the brochure could be brightened up with photos and etc., which could be worked out in detail by the Administrative Secretary.

X. Office Staff

The Committee voted to give the Administr-ative Secretary a seven day vacation after the close of the school year. This should be done with consultation of the Atlanta Advisory Committee.

XI. Field Secretary

The Committee voted to ask Miss Diane Nash if she would re-consider the offer to become Field Secretary of the Coordinating Committee.

XII. Cooperation With Student Protest and Civil Rights Groups

The Committee passed the following resolution: "we recognize the ever increasing need to broaden the base of the sit-in efforts and the Coordinating Committee is going on record as willing to participate whole-heartedly with each co-ordinating effort convened in good faith to supply this broader base for massive student nonviolent direct-action.

XIII. Election Of SNCC Chairman

Mr. Charles McDew of South Carolina State College, Orangeburg, S. C., was elected to serve as Chairman of the Student Nonviolent Coordinating Committee until the next meeting.

XIV. Next Meeting

The next meeting of the Coordinating Committee will be held the week-end of April 8-11 in Louisville, Kentucky.
