ANONYMOUS LETTER POSTMARKED OCTOBER 7, 1963, AT  
INDIANAPOLIS, INDIANA, SIGNED HIS MAJESTY THE GRAND DEACON  
TO MIRIAM COHEN, 6140 KINGSLEY DRIVE  
INDIANAPOLIS, INDIANA

*Victim*  
On October 29, 1963, Robert Gordon, Anti-Demonstration  
League, Indianapolis, Indiana, advised that he had been in  
receipt of a letter directed to Miriam Cohen, 6140 Kingsley  
Drive, Indianapolis, Indiana. He advised that Miss Cohen has  
been active in the South on the part of integrationists. He  
also advised she is presently in the South on behalf of the  
Negro movement.

Mr. Gordon advised the letter was made available to  
him by her family and that they related at the time that a  
small cross had been burned on their property but that no  
report of this had been made to the police department as they  
wanted to avoid any publicity in the matter.

He made available the letter which reads as follows:

"Knights of the Ku Klux Klan  
"Of  
"Indiana

"Miss Miriam Cohen:

"You are about the lowest scum on earth along  
with all the niggers that you run with and sleep with.  
What are yiu and your folks going to do when you give  
birth to one of them black half breeds.

"Your movements have been watched very closely  
sence your return from the South. When that Cross was  
burned in your yard that was for you to take warning and  
stop your running around with them niggers.

"We meant for you to take that Cross as a fair warning but it seems that you dont no one when you see it. To the members of the Klan you are just a tramp that has no pride in her self and therefore you have been found GUILTY by the members of this order and you shall be dealt with as we see fit.

"Miss Cohen you have asked for what you have coming to you. So be on your guard for the eyes of the Klan are upon you more now than ever.

"We know all about your Aug. 25, speech at Hillside Christian Center. You see we have many ways of finding out what is going on in this city.

"We hope that this will be our last letter to you, but it will not be the last time you will hear from us.
