National Chairman Floyd McKissick explained the purpose of the meeting----to work out the formal organization of the NAC and certain internal problems facing the national organization.

Mr. Farmer reported on his conference with staff members noting that it was a good meeting. He asked for permission to review the matter further and to make a report to the next Steering Committee meeting.

Bob Curvin requested a more detailed report in writing to be shared with NAC members before the next meeting. It was decided after discussion that such a report should contain guidelines for staff behavior and a clarification of the roles of the different departments within the national office. It was also suggested that the recommendations of staff regarding the national office be made known to members of the NAC.

Bob also requested that the committee for the evaluation of national office facilities be continued in existence.

Gene Tournour, field staff member and supervisor of the Chicago Task Force, submitted a request to the national office for continued financing of the Northern Summer Project. Tournour presented the following past bills and projected expenditures for the next two weeks.
