

THE WHITE HOUSE

DEAR MR PRESIDENT: SINCE THE MISSISSIPPI FREEDOM DEMOCRATIC PARTY BEGAN ITS FIGHT TO BE RECONGNIZED AS THE VOICE OF THE DEMOCRATIC PARTY IN MISSISSIPPI WE HAVE ASKED THAT YOU MAINTAIN A "BENEVOLENT NEUTRALITY" IN THE DISPUTE BETWEEN US AND THE SO-CALLED "REGULAR" DELEGATION. AS YOU KNOW, THIS ISSUE IS NOT A ROUTINE POLITICAL ONE BUT RATHER INVOLVES A FUNDAMENTAL

MORAL QUESTION: A QUESTION WHICH GOES TO THE ROOTS OF OUR POLITICAL SYSTEM AND TO OUR SYSTEM OF JUSTICE. THAT QUESTION IS WHETHER THE DEMOCRATIC PARTY WILL STAND FOR FAIR POLITICAL REPRESENT-ATION, AGAINST VIOLENCE AND OPPRESSION AND FOR THOSE PEOPLE WHO ARE DENIED THE RIGHT TO VOTE IN MISSISSIPPI.

IN THE LAST FEW DAYS THE CHARGED ATMOSPHERE OF THE CONVENTION HAS LEFT THE IMPRESSION THAT ONLY YOU ARE IN A POST OPPOY MAKE CLEAR THE DEMOCRATIC PARTYS POSITION ON THE BASIC ISSUES INVOLVED IN THIS CASE. A GREAT NUMBER OF MEMBERS OF THE CREDENTIALS COMMITTEE HAVE MADE CLEAR THEIR WISHES TO FOLLOW YOU IN HELPING THE MISSISSIPPI FREEDOMS DEMOCRATIC PARTYS CAUSE. INDEED, THESE DELEGATES HAVE ALSO MADE CLEAR THEIR INTENTION TO WAGE A FIGHT FOR THE "MFDP" ON THE FLOOR OF THE CONVENTION -- IN ANY EVENT. BECAUSE YOU HAVE DEMONSTRATED LEADERSHIP AND WISDOM IN THE NAME OF CIVIL RIGHTS AND IN THE NAME OF FUNDAMENTAL DEMOCRATIC PRINCIPLES, WE URGE YOU TO JOIN WITH THESE DELEGATES IN SEATING THE ONLY MISSISSIPPI PARTY CHOSEN DEMOCRATICALLY AND WHICH IS REPRESENTATIVE OF THE PEOPLE IN MISSISSIPPI - THE MISS-ISSIPPI FREEDOM DEMOCRATIC PARTY
