Minutes, Organizational Committee
September 22, 1964

Minutes, of the September 8th regular meeting were read.

Mrs. Carstens suggested we express our thanks to Mr. Fisher, the Accountant who handled the bail account.  Corresponding Secretary - Recording Secretary
 Treasurer

Motion made by Mr. Edwin Wilson, seconded by Mrs. Bridgeforth, was carried that a nominating committee be selected to bring a slate to the general membership, to be elected at the next regular meeting. This was set for Wednesday, September 30th, at the home of Mrs. Judy Newman.

Mrs. Newman and Mrs. Bridgeforth volunteered to produce the Newsletter.

A motion was made by Mrs. Siegel, seconded by Mrs. Newman and carried that we send the \$2000.00, being held on hand, to Bob Moses at COFO, with letter from the Richard Wilsons, enclosed with the check.

The Treasurer's report was made by Dr. Johnson.

Mr. Edwin Wilson was authorized as Provisional Bail Chairman to find out about methods used by other groups in handling bail arrangements. He asked for a committee to help with bookkeeping. Mr. Sidney Harris volunteered to serve on this committee.

Mrs. Siegel was authorized to extend the Post Office Box service.

The meeting adjourned at 10:30 PM.
