Creative (musical, dance, art, writing, film)

Organizational (working with groups of children, high school students or adults)

Medical (pre-natal care, dietetic, public health)

Programmatic (background in federal farm programs, co-ops, small business administration)

Teaching (particularly basks English and math, literacy for adults, remedial reading for children and Negro history)

Hiring preference will be in the following order:

1) Native Mississippi and Louisiana Negroes

- 2) Southern Negroes
- 3) Northern Negroes
- 4) White males
- 5) White females

Applicants must commit themselves to a minimum of six months in the south, but preference will be given to those whose commitment is a year or longer.
