

Community Church - 40 East 35th St.

On Jan. 18th, we decided that each monthly membership meeting should include a report and/or an outside speaker, so that the meetings will be stimulating and informative. Accordingly, Mrs. Annie Devine came up from the Washington FDP office to report on the work of the FDP.

Mrs. Devine spoke feelingly of the work of our children in Miss. "They were always giving up their money, the money they had for food and daily necessities, to help some Negro that they knew nothing about," she said. She told us that many a Volunteer lived on peanut butter at times, until the next "pay-check" arrived from home.

Mrs. Devine stressed the fact that she would not be here - the FDP would not exist - were it not for The Kids - as she called them.

It is clear that the success of the FDP, in getting 149 votes in Congress, against the seating of the 'regular' Miss. Reps. - this was very much beyond the expectations of the FDP leaders themselves. Mrs. Devine told us that on Jan. 4th, the day of the Challenge in Congress, we were only sure of 22 votes against the seating of the "bad guys."

The additional 127 votes obviously came from grass roots works all over the land: such as the work done on Long Island which made 4 out of 5 Congressmen vote on the side of FDP. And in the Bronx, all 4 Reps. voted on our side, showing what hard work can do.

The conclusion is clear: if we work hard between now and June 1st, we can get the remaining 72 votes needed to get Congress to vote for the calling of new elections in Miss.

Bill Kunstler stressed once more the importance of new elections in Miss. IT WOULD BE THE MOST IMPORTANT EVENT SINCE RECONSTRUCTION, IN THE FIELD OF CIVIL RIGHTS, he said. First, there would be a voter registration campaign that would make last summer look like small potatoes. And there would be a fight: every dog catcher in Miss., not to mention the sheriffs, would fear for their jobs, with ~~Negroes~~ registering to vote in such large number Negroes

Bill Kunstler stressed that the Challenge is now being taken seriously in the South, since 149 Reps. voted in favor of the challenge. This can be seen from the Southern press, and from the fact that the leading Southern officials are complying with our subpoenas.

With such a good chance of getting new elections for Miss., with Negroes registered, the work of the FDP takes on more and more ~~importance~~ importance. Its work being the fruit of our childrens' summer in Miss.

It was agreed that we should explore ways of helping the FDP, in our special role as parents. The Osmans, who are Brooklyn parents, will do what they can. Willard Fra-

is very involved in the raising of money and other FDP work on Long Island, but he will also help in the work of the Parents Group in support of the FDP.

Jane Hodes said she would contact ~~HHHHHHHH~~ Trudy Orris on this phase of our work. (There is a need for women who can give daytime hours to phoning and office work in connection with the Challenge.)

And Gladys Blum will of course be contacted when she returns from vacation, about Feb. 22nd. The Blums are also working for FDP on Long Island, but will also give some help to the Parents.....

On Sunday, April 11th, there will be a dinner dance for SNCC - FDP, at \$100 a plate. It was felt that the Parents would somehow be able to raise money for a table.... Details later.
