## EXECUTIVE COMMITTEE MEETING

Place; Holly Springs, Mississippi

April 12th thru the 14th.

Chairman: Cleve Sellers

Ruby Dorris gives a short run-down on the SNCC personnel and where they are now working to her knowledge. She states that some of these people just float and don't do any work.

Foreman - Who are those people that don't do any work?

Ruby doesn't feel that they should be named but handled by the Personnel Committee.

Silas - We should discuss this here and now, because this problem of floaters and why they aren't working is becoming a very big problem.

Foreman - I feel names should be called. We can't discuss people or the problems concerning them without knowing their names. Besides, this organization has a right to know what I'm doing or anyone else.

Ruby - I'm not saying they aren't working, it's just that the problem isn't only that. The problem is larger concerning people who are supposed to be stationary.

Cleve - The chair is now open to proposals on how we should proceed.

Foreman - Atlanta should be notified first when people move from project to project so that we will know the whereabouts of them at all times. Someone should have a record of everyone's whereabouts. We've talked about it before, but now something has to be done.

Silas Norman - One of our problems is that a lot of people on the Alabama Staff seem to like Atlanta and our cars are always there.

We had a staff meeting and I told people that the cars shouldn't be taken out of Alabama. Someone said we couldn't tell people what to do. Well I'm telling them. The cars do not belong to any one person and it's about time a lot of people realized this little fact.

Ruby - Maybe we could take out a lease on the cars being in a certain state and they must have permission to take the car out of the state. It also seems simple that people could call Selma and explain they have to leave the state and to leave an address where they could be contacted.

Jim Jones - I do not agree that the lease be gotten, because the person it is leased to might possibly be the trouble maker.

Foreman - I'd like to bring this discussion back to the point. In Mississippi there is a very serious problem off leadership or project directors, poor morale and no programs.

Mississippi just had a 3-day meeting and there was a lack of programming. First of all, Mississippi should meet on the District Level because the state meeting is too large.

Secondly, In this meeting a lot of people said that their project directors couldn't tell them what to do and if their checks were cut off, it wouldn't matter. Now, how do you deal with this?

Muriel - You have a riff between project programs and state oriented programs. When Moses left, there was a vacum. People use to be able to go to him about their problems, now they have no one.

Stokeley - I personally know a lot of people who are floating now, but have worked very hard in the past, in Mississippi. This is because there are no programs. That is what happened in the SNCC, SCLC thing in Montgomery. SNCC had no programs.

Muriel - How can you say that when we have 82 counties that need to be worked.

You can't expect people

Stokeley - There have been no new programs. You can't expect pe to go out and talk FDP each and every day.

I'm at the point where I feel we need discipline concerning programs. You see, how can we question others when people like programs. You see, how can we question others when people like Moses and Cox get away with a lot of things and are never questioned about them.

Foreman - We have a staff which is oriented to breaking ground, mobilizing people and getting them to think they should move on

Breaking ground used to be a program. Now it is no longer needed in Georgia or Mississippi. We don't have the same problem in Alabama that is happening in Mississippi because it is Virgin territory.

The whole civil rights movement is entering a new phase. We've never addressed ourselves to the Poverty Program. This should have been on the agenda.

Another thing is the Civil Rights Bill. We should discuss this because it will be important to a lot of people that we work with.

Stokeley - We've always talked about Staff Education. When people ask us how to get their streets paved, we say "go down to the courthouse". When they want street lights, we say "go down to the courthouse". We have no knowledge of how to get these things done because we don't have that information.

Featherstone - That not true Carmichael because I know how to get the streets paved.

Foreman - Maybe you do Featherstone, but the field staff doesn't know these things or have that type of information.

Marion Berry - I think our problem is that we no longer mobilize around Direct Action.

. Cleve - We seem to have gotten away from our first point of talking about personnel and the problems of such.

Ruby - We should ask Frank Smith to work on programs that he can carry to the field. Those programs are very expensive when we have to send people to D. C. and he could come to the state of Alabama and present them. Or Mississippi. He could then hold, workshops in these various states and it would cost less than sending the people to Washington.

Ralph Featherstone - How do you decide about who's producing or who's not producing: Then what do you do after you decide this?

Muriel - What do you do after you finish demonstrating. You stand in front of a hamburger stand for 3 weeks, but when you get in, you don't have fifteen cents to buy the hamburger.

My premise is that Negroes are going to have to fight for everyng they get. We'll just have to find a way to keep people prothing they get.

Federal Programs aren't going to do anything and you know this before you start out.

The staff of Mississippi is tired. They just don't have the energy to start over knocking on doors."

Jim Jones - I tend to agree with Muriel. How do we plan programs and start over to inflict them on people.

Foreman - How is it you can live in a community and can't plan programs for that community. You know the problems of that community and in this way you can plan.

Marion Berry - The Civil Rights Movement is becoming very complex. I think you can plan some programs. Freedom Houses are bad and should be done away with; move into the community. This way you could get a better idea of peoples problems and be in closer contact with them.

# John Lewis relieve Cleve Sellers as Chairman

Betty Gorman - Recommendation - The staff mailings have mounted greatly and we'd like to know what these mailings have to do with organizing. I would like to state here and now that people who do mailing should be told to mail out more information on what is pertinent instead of so much junk.

Muriel - We need to get rid of the middleman. How do you deal with people who tell you they're going to shoot you if you take away their cars?

Ben G. of Arkansas - I think we should start talking about individuals and if it takes firing most of the staff, we should do it. We should pull cars and checks by whatever means it takes.

Cynthia Washington - Ruby sent someone to pick up the truck and when Lee Bankhead found out why he was there, she put him on a plane and sent him off.

Ben - I wish someone would speak out about this type of thing happening se we can talk to it.

Marion - I don't see why we can't fire people.

Fay Bellamy - Where on earth did the idea come from of being able to hire but not fire?

Foreman - That isn't the whole issue. We have been caught up in a lot of the Mississippi problems.

Bill Hansen - People can stay around any town they want to forever, but they don't have to be financed by SNCC.

# Tom Brown relieves John Lewis as Chairman

Marion - Doug, why do you feel you can't fire people.

Doug - Because there was a girl on staff in Hattiesburg and she said "I can't be fired and I'm not leaving town". Her name is Johnnie Winchester.

Staff - So what did she do?

Doug - She did eventually leave town.

Foreman - We should have some program where people can come to a certain group of people and say "I have a problem and need some help".

Lewis - I'm strongly for people shaping up or shipping out. If it means that this committee has to send out letters saying your services are no longer needed", then we should do this.

Ruby - We should set up rules on people leaving their project areas and all the other problems that different projects have with their people so that we'll have something to go by.

Bill Hall - We should set up Personnel Committee travelers who can visit projects and see what's going on on the other projects. I came here personally to whitewash a project. I went to this project and was thoroughly disgusted.

It was later stated that Bill was speaking of the Cambridge Project.

Marion - I think the first thing is to get an effective and working Coordinating Committee and also an effective Personnel Committee that will work and will also sit down and discuss, with personnel, their problems and try to help where they can do so.

Bill Hansen - I don't see how we can have any one or two persons go into any area and evaluate within two or three days what the project is about.

Foreman - We should talk for a change about Alabama, Arkansas and S. W. Georgia because most of these problems we're discussing are only in Mississippi at the present time. Maybe we can learn some-

Tom Brown supports this. There is general consensus among the Executive Committee members.

Foreman - Suggests that Ruby go down list of people on staff and take some sort of action on them.

Muriel - Ruby, who is on the Personnel Committee?

Ruby - Personnel Committee consists of myself, Cleve Sellers, Jessie Harrison, Amanda Purdue and Wilson Brown.

Also, the Freedom Singers, sometimes. Erin Sims - Can't people leave in time to take the train or bus instead of flying at the last minute.

Here there began a long discussion on why the Freedom Singers would have to fly anywhere, because they usually know their assignments well in advance and could either drive or take the bus.

At this point someone asked how much the singers were paid weekly.

Ruby - They make \$45.00 per week.

Muriel - I don't understand why they have to have \$45.00 for traveling expenses when people usually take care of them when they re on the road.

Ruby - The original Freedom Singers used to get \$60 but it was cut to \$45.00 and I personnely feel that they need \$45.00 for various purposes. There are times when the have to have hotel rooms and money if they get stranded.

Staff - Let's get back to Air Travel Cards.

Foreman - It was an easier system to have Air Travel Cards. I have a Q. Card and am responsible for signing payment slips. Persons who have or did have these cards are: John Lewis, Bob Moses, C. Cox, Ivanhoe Donaldson, Cleve Sellers, Don Harris and Prathia Hall.

Pogg S.: found that people from Miss. were willing to leave their projects, thought they should stay.

Muriel people call for about a week wanting to go to Ala. Silas has asked no more people to come. Muriel tried to disuade them.

Foremon: I called Cleve. Also chartered a plane to Montgomery. We had previously committed radio cars and doctors, Discovered King not there, etc. knew people would get hurt. Asked people to go (called Cleve)

Silas: Not trying to focus on people who are running in and out but on those who are staying. Thinks people came because of frustration on their projects. Jesse: What Selma did to Miss. staff. people who had responsibility in Miss. left the state, this hurt Mississippi. Bill Ware was one of the few who realized his responsibility to Beloni.

Ruby: B ill went to Selma out of frustration in Belzoni.

the staff there.

Foremon: to Silas - Do you think this motion is the best way for us to deal with this./Silas doesn't think it is his responsibility to find people. All should be subject to discipline. If Bob is above discipline, he should be project director.

Arlene: Personnel Committee should deal with this.

Bill: Would withdraw motion if it is understood that we will come up with a list of problem people for the Personnel Committee.

Marion: Propose -- 1. Find out howarresable (?) SCLC is to working with SNCC

2. Use June and early July for Washington lobby, bring students south.

3. In the south use southern students to lay ground work to bring peole south to take advantage fo voting bill (must be prior agreement.).

4. FDP should tell us how many people they want.

--:

Note from typist: The minutes at this point have become very difficult to read, so I must start just summerizing them.

Roberta Geller now has about 100 applications to process. Guyot asked that Mississippians be given priority in appliying for FDP summer program. FDP has asked SNCC to help recruit for the program through our northern offices.

Betty: We have a program for June -- sudents ging to Washigton to lobby. We will screen and orientate those coming (for FDP or what ever).

Marion: We can't recruit students for summer on these vagarities.

Foremon: We need to talk about what happens in Sept. after summer.

Must have a significant number in Washington.

Betty: Northern offices felt that these recruited would have to do more than get go to Washington. Most of them will think they'll get to go south if they go to Washington.

Bill Hall: Why not recruit black students. Have southern regional conferences for African and Southern Negro students.

Marion: We musn't underestimate northern economic and political support.

Jesse: What are the objective in getting Northerners. No organization is recruiting southern Negroes and we're going to end up having to do that anyway.

Betty: We must begin to interpret to northern students why they can't come.

Silas: If we concentrate or recruiting black southern students as we do for northern whites -- we'll have more than we can handle.

Marion: We need people to organize around the voting bill.

Jesse H.: Wehave more people in the south that we can use to organize; therefore we don't need to get more people from the south

John Buffington: If you want political support for the challege, you bring people down, wake them up and make them aware. Therefore you need as many people.

Cynthia: White folks intimidate Negroes from doing there work. You can get lots of Negro students to do the work.

John Lewis: You should get as many people a possible involved in the movement. We have to raise larger questions --whether or not we want to have Negro people place their names on the registration book.

Ben G.: We just don't want their names on the books, but we want to educate the people -- white people can't do as much rood as Negro students because the can't relate to people as well. We can't use 100 white volunteers this summer.

Fay: Why don't you just organize the sons of senators and congress men, since all you just use white kids to help bring pressure.

Foremon: Priority should be given to southern Negroes and southern whites. Las t summer we had to make the country aware of the Miss. situation. Therefore, you brough t the whites. Then came the challenge and we learned from the challenge that you couldn't just try to condemn southern congressmen, you and to get the support of norther congressmen. Therefore you use northern whites. We went outside the United States and got Canadian support for Selms We have to ask how to build a broad movement in US. You do this by involving everyone, white or black What we say tactically is just give us your money and leave us alone.

Marion: Let's go back to what John said - Do we want to get people registered or is it just an organizing tool. We have to have broad support to bring about the change we want. The voting bill will not work and the way to show the country it doesn't work is to have people go down there and mess with it and if you have northern kids down there and they will bring protection for the Negroes and help get better laws.

John Ruffington: SNNCC is racist. They think just black people should do everthing. How in the hell can you have a national issu without involving the nation? I'm sick of "Black" and "White".

Ben G.: We aren't communicating. Marion is talking about mobilizing white folks. I'm no racist.

Bill Hall: I ain't no racist. But Jimmy Lee Jackson was killed and no one said anything. Let it stand that way, when white folks get killed everybody jumps. White folks have political power. Let them deal with politics and let Negroes work in the south.

Jimmy G: The vote ain't the answer. People can vote in Harlem but its controlled who they can vote for.

Marion: I don't want the vote controlled in Mississippi. We've got to get political education. How to avoid the corrupt politician (black or white) from getting there, so we register tham and educate them, hoping they don't get captured by corrupt politicians. In the month of June you have 30 days to get some good political education with those white kids. Further more, what makes you think the Negro students who are middle class will organize better than the whites.

John Lewis: Lots of SNCCpeople will be running pretty soon. Julian Bond is now running in Atlanta. He ahs a good chance of winning according to Cleve Sellers who got the information from "Ivanhoe SNCC folks should go and establish residence and run for office.

Lee Bankhead: We have people running next year and we will have to vote for them. Therefore we will have to register.

Jimmy Garret: The same people will run the Democratic and Republican Parties. Voting shouldn't be the end.

Fay: First problem - do we just want to get people to vote - Therefore we c an work with L.B.J.

Marion: People must be educated politically.

Ralph: Let's get deeper. I think SNCC should pick up a new motto: "One man - Three Squares". We are as radical as we can be. I think we should talk about economics therefore people have diverted us to politics. Food is more important than politics.

Foremon: In the discussion of economics, I just hope that we do this some people in this organization won't say why do we have to ret people fed. Because some people will say that people in the D lta should stay poor. We must also include politics, however.

Hansen: The reason we want political po wer is to change things economically.

Ralph: That's Bullshit! Economics controlls politics.
Fay: We've just been talking about the vote, vote, vote,
Marion: We all agree that we should have a staff meeting in May.

Muriel: Districts and states may not want additional people, therefore the program can't be rigid.

Jim: We can't talk about programs beyond just dealing with the summer project.

Lee Bankhead: What kind of education has the staff received up to his point? Many staff people thalk of personal freedom and what they will and won't do. How can these confused staff people wrk in the communities? We should associate the right to vote with economics - broaden voter registration - talk about the MFDP.

Muriel: There are amany inconsistancies in SNCC and what we say and stand for - we really are concerned with the society - we're too absorbed with time limits.

Mrs: Palmer: The FDP is still stressing Freedom registration, because we realize that it will be a long time before real registration means anything. There's plenty of time to work and dewait.

Muriel: We've all been in organizations which have tried to for years. I don't think we can organize freedom. We'll get tied down in perpetuating the organization and lose sight of the idea.

Foremon: I'm calling for a staff meeting because we need to evaluate programatically in view of what is happening in the country.

Marion: What are we coing to do in terms of recruiting?

Ralph: We agreed already about what we'll do.

Marion: We have to sharpen the focus on the D.C. lobby. Many

moves were made to adjourn. It's 11:30 and people are tired and losing interest.

April 14, 1965 Holly Spring, Miss. Executive Committee Meeting

John Lewis: I don't feel we should critize any Civil Rights organization openly and in the public eye. We have to realize that its a waste of time and energy to answer to the charges made by different staff in different parts of the country.

Marion: We have to realize that there are forces in this country who would like to see SNNCC, SCLC & CORE split, because they know that if we ever work full together, we would push the NAACP and the Urban League and others out. This is a pact that should be strenghtened. There could be a forum for critizing SCLC or anyone else, but not in public. What we have to do is try to radicalize King. Those of us who have been around for awhile can see the great change in King and there are members of SCLC who are pushing for the same thing. As to who speaks for SNCC, we can make it known to the press that only the Executive Committee speaks for the SNCC. In this way you can attack a lot of the crap that is said by individuals.

HJohn Buffington: The only thing about a discussion such as this is that it never gets discussed in the field projects. We know it, but no one else does.

Ivanhoe: SNCC is different from SCLC. That's why we're two oranizations. We think and operate different. The question is
where do you concentrate your fight. You see, I just don't think
the organization should lambast SCLC. I don't know about CORE,
but people look on SNCC & SCLCas the moving force in the south.
In terms of the public, within our organization we should have
a refinement of our programs, becasue the press has no continuity
of what our programs are supposed to be.
I just feel there has to be a policy in SNCC that we are different from SCLC & CORE and go ahead and work out our program.

Muriel: There should be some fostering of a closer relationship between the staffs of a organizations that have we work togather Such as in La. with CORE wanting to have more contact with the Mississippi staff. If we are to work togather than we have to understand each other.

Marion: We do need coalition with SNCC#SCLC-CORE-NCC. We do need to meet and understand that what happened 6 months ago in this country is no longer happening and that changes are happening fast. We've got to understand that we can't stand still.

Ralph: Are you roing to talk about playing politics? If so, then I think we can really get down to business.

I think John is right not to critize other organizations.

Fay: We should realize that to the press we are not individuals but SNCC and a body or group should be designated as spokeman for sncc.

Bill Ware: I don't think this should be done unless we intend to hold workshops for the staff to notify them of this.

Foremon: We have representatives from each area here and they can relate this. Also, ''m roing to the 5th district and the 3rd and can relate this to the staff there.

Fay: This could be put on a separate sheet and sent out with the minutes.

L.A. office --

Jimmy Garrett --staff Liza Kaye Nathanielson Mary Anderson

There will be a typed report by Betty Garman on L.A. and Hollywood.

L.A. office --

Inocome -- \$6,832.05 Total Net Raised - \$1,168.83 Expenses-- \$5,663,22 Sent to Atlanta -- \$ 900.00 Salaries-- \$2,925.00

Betty: I feel that Jimmy Garrett should speak because he probably has more information since he works out there.
It appears that Cliff Vauchs is fund raising in Calif.

Ed Wilson - office mgr. Nickey Vernon - Answers the phone and never knows where the staff is. Jimmy Garrett - Out organizing

We are never able to contact them or get any reports from them except expense reports.

Jimmy: Let me talk about L.A. first (Long Beach, San Diego, Santa Barbara, Bakersfield). I decided to work where I could because of the shit in L.A. and the kind of imare they have. Levi Kingston was running this office when I got there because of the way it was set up. I came here to find out --- I didn't come here to make a report.

I know the people and areas I workd with and in and that a lot of money is sent down to Atlant. I raised hell with the Atlanta office and came down thw last time to resign because I couldn't work out of the L.A. office. I'm working on college campuses and in small areas to organize Friends of SNCC groups and the small areas to raise small amounts of money.

Betty: I stated that all F. of SNCC groups should work in direct contact with the Atlanta office.

Jimmy: There were no SNCC demonstrations in L.A. The United Civil Rights Comm. called a rally which turned into a demonstration. Later CORE got involved in one. The Federal Building was closed because of the first demonstration and the people sat down in front of the tracks.

Ralph: I received a call from Nancy Cooper that the people in Washington, D.C. said that "we were down hwere undercutting the washington conference" and we were trying to cut the money down among other things. I don't know how that came about. So I asked her who they were and she said Courtland Cox and Dona Richards said this. They weren't even here at the meeting at any time. This is just an example of how remours get started.

Ivanhoe: There was a clipping from the LA Times quoting Jimmy Garrett and part of it was quoted in Time (Mag., I think) "I don't give a damn about SNCC, all I care about is Jimmy Garret". The other statement was something about Communists being in the organization and "we infiltrate them".

Jimmy: First of all I didn't make those statements. The Colif. papers took this out of context. Also we have a clarification of these statements and intend to send a copy of it to the Atlanta

Ivanhoe: "e all know this is done and should try and be a little more careful of statements we make.

Marion: First of all if we receive a call from the reporters wa don't have to talk to them. Refer them to the Atlanta office. Secondly; they (reporters) shouldnot be in on our meetings. Ask them out.

Jimmy: Carl Fleming, a reporter, did interview me concerning the communist thing for Newsweek and did take the article out of context. Now I have the tape of the interview and Newsweek is going to print a clarification of this article.

Betty: So what do we do in a case such as this. Most Northern offices are in contact with the newspapers. Do discontinue this or what?

Jim: (Foremon) I don't think we can discontinue this because northern offices have to habe this contact.

enge wand .

This is why the communications dept. has to be built up. Also, the thing with SCLC has to be discussed. We have to realize that we have to have closer contact with the Atlanta Communications Dept. and let them know what is happening.

Also, we used to write Field Reports. Now that no longer happens. Many things that are going on in the projects, we don't know anything about. We need a set of writers in the organization who can set up the facts.

Tom Brown: I'd like to emphasize the importance of Field Reports This covers a lot of situations and advance proess releases can be typed up. Records are very important and the handling of them by the communications Dept.

Ivanhoe: Communications Dept. can't operate any better than this organization and the field projects reports are not at the base of this. We do have some writers but we never utilize them (ie Francis Mitchell and Jerry DeMuthe)
Also Eric Morton never stay in Atlanta ever 9 straight days. We have Jack Morton, who is a very good writer, layout man, etc. who has been comming to the Atlant office since last Sept., but we have nothing for him or any of the others to do or no way of utilizing them because there is no one the hold them together.

Jim: I still say we should have a central place for information to be given out.

Marion: We have to maintain contacts with the press. We should maintain contacts in many areas. We have to have a basic policy so that there will be some co-ordination among SNCC inorder that we do speak to the press, the statements will be similar.

Betty: When we have Speakers Bureau workshop and Communications workshop, this will be a way in which to avoid some ot the past boners in talking to press and also, people who are used as speakers.

E.C. -- Cleve will take care of programing for setting up this workshop.

Marion: Back to L.A. We should clear up the financial situation there. Also, Jimmy, do you want to be a fund raiser or an organizer.

Jimmy: I'm organizing Friends of SNCC groups. I was told to organize Friends of SNCC groups to reise money. This is what I'm doing. Also, when I ask for supplies, I'm never able to getthem.

Betty: The reson you didn't ret a lot of supplies is because we were broke and could not pay for it.

Cairman: Reads a letter dated March 5th, 1965 from Jimmy Garret to Cleveland Sellers.

Marion: Most of the people haere don't realize how crucial the situation is in L.A. They (staff) seem to be "Freedom High" and I don't k feel we can operate in that way. Clffi Vaughs is working on raising large sums of money in L.A.

Attempt to discuss letter from Jimmy to Cleveland. (Sellers)

Foremon: The works in the office full time?

Jimmy: Ed Wilson and Cliff Vaughs.

Foremon: I'm going out to L.A. to see what's going on. Is Levell on our staff?

Jimmy: She's not working, but she's on our staff. She should be dropped. Chico Neblett says he came out there for a rest. Not doing anything. Ron Bridgeforth resigned 4 weeks ago.

Cliff is working. Ed Wilson -- \$30.00 out of petty cash per week.

Betty: Cliff is working out of a house in L.A. Nickey is the only one there when I call. To contact Jimmy, I had to call has house office, Levell, etc. and never reach hi, . Anits Whitney says Ed works out of his house.

Ivanhoe: I don't feel that we can afford to run an office that can't bring in 100,00 dollars per year. You have an office mgr. that will take care of business and handling the fund raising. He can't do it by working in the field.

Tom: I think that Jimmy is not interested in being an officer mgr. Jimmy do you want to be office manger to handle the office, mass fundraising, dealing with a mass of people and being responsible for all this?

Bill Hansen: Foremon, when are you fgoing to L.A. and how long can you stay?

Foremon: I have to go out there on May 4th and can stay about 4days.

Bill: I would suggest that the Exec. Comm. mandate Foremon to go there and stay until the situation is cleared up. That he be given the authority to clear up this matter and put someone in as office manager (directo).

Foremon: I'll go.

Stokeley: I suggest that Ivanhoe go along with Foremon.

Ivanhoe is working on the campaign.

Foremon: I'd like to have a written report from Marion Barry. Ivan has to go out there on the 23rd and Betty Garman.

Stokeley: The Campaign is over on May 5th and Ivan can meet himm We're always putting Foremon in a box to do things alone. Then when he does it, we yell and scream.

There is a consensus of the group that Jimm and Ivanhoe be mandated and given the authority to hire, fire and to clear up the situation

Foremon: I aske that Betty: Garman to with me to L.A. She does have informatiom that is pertinent to the operation.

#### PROGRAMS --

Ivanhoe: Regarding Julian's campaign and soliciting SNCC's help. Funds already appropriated - \$500.00 (personally borrowed by Ivan for qualifying fees. Another loan of \$100.00 for the payment on the office and telephone. Some funds were solicited from the business community. Can SNCC endorse \$1,100 for the campaign. Maybe some of it can be paid back.

Bill Hansen: I move we endorse it. Bill Ware: Why?

Ivanhoe: The issues he stands for good for the Atlanta Community. Good for his kind of candiddate (young, black and radica) To get a Negro from this district it will be the first time since reconstruction.

Featherstone: "That will Julian do if he loses.

Ivanhoe: I don't know. Ruby: Regarding resources, Julian can get help from the Atlanta community an not ask for as much help from SNCC as we have put into other campaigns (C.B. King, etc.)

Ware: Julian as an individual can't corrupt the organization. Others were reflections of SNCC's program.

Foremon: 1. Responsibility of organizing districts in campaigning is to make community financially support it.

2. Campaign should be given national publicity.

3. Some staff (Ga.) and local people to come last few

days to do work in the area.

4. Would urge Julian to set up Ga. Young People's Party, or whatever - since they can vote at 18. Should use office to organize young political student union along congressional district lines. Should have counter force to Ga. Voters Learue.

Ruby: We should write off the \$500 qualifying fee. Ware: Let's just give everything as a loan indefinately. We can decide what to write off later.

Ivanhoe: Will be using campus students too

WASHINGTON CONFERENCE --

Featherstone: Courtland, Cobb, Bob Parris and Dona Richards -To have a lot of students in Washington for conference (2 days)

1. Orientation on FDP challenge

2. New/Free Elections
3. Possibilities of violence when legal barriers fall
4. Voting Bill - What it means

Friday - Ask students what action can be taken around MFDP

Saturday - Summer Program - Coming to Wash. & going south.

Muriel: "ho's running the conference.

Featherstone: Higgs, Guyot, Cobb, Featherstone, Bob, Dona, Cox

Foremon: People's conferences are mood but practically imposs-ible to be held in time; Arkansas has announced its summer program. People shouldn't feel hung up about program if people's conferences are not held.

Ivanhoo: What is SMCC's summer project?

We will support FDP's program and Arkansas'. Ala. and Ga. are not worked out.

We should hold people's conferences before the summer, but rather latd to wait until then before making any plans.

All policies must be made clear and recruitment should be done through the northern Friends of SNCC offices.

Betty: I had thought of northern area conferences before Wash. Courtland had planned Chicaro conference - student wide. Contacts were made with SDS, NSM (Tom Hayden, Bave Dennis) to meet in Atlanta and talk about Chi. conference. Place was cha nged to Washington (conference).

When students meet in Washington they may constitute a coordinating committee for Wasington activity this summer. It is hoped that the Friends of SNCC can cooperate within that and that there won't be

Tom Brown: Can the E.C. endorse the So. Regional conference to discuss new programs.

Muriel: What about massive black belt congress in July as follow up to challenge.

Foremon: Muriel: should prepare apaper on how to jump outside societ Many Southern Negroes will be roing to Wash. Exec. Comm. should suggest to Bill Hall to get together with kids about summerdistribute applications. We must find out why South Carolina conference didn't come off. Betty should be at the conference as should many in the room.

Featherstone: I understand the FDP is going to have applicatons. FDP is asserting independence. I was sent to Washington be the Executive Committee to work in the community; Jan Goodman told me Willie Johnson was doing that.

Silas: What about April 24th conference. (Free Elections)

Betty: FDP called meeting for northerns re: lobbying, etc. to

boost northern lobbying around challenge. Want 1,000

Feather: Problem between FDP and SNCC at Washington conference. We can't tell people what to do.

Ruby: is anything written? What should we tell people. What specifically will they be doing.

Feather: That's not available now. You have to weit until this weekend.

Ruby: Assignment should be made before they come to Washington.

Ivan: What's the program in area outside of Miss. other than V.R.

Ware: Could we assist under Miss. program in relationship to FDP program and that this action is operated or initiated from Wash.

Ivan: I don't see how this can happen.

Jim: FDP WAS GOT to be made to function because it does not hang us up. If they want to shve demonstrations in Miss. this summer, we're just going to support them. If they want people to come into Miss. we'll just have to help. We're going to have to push for a Washington lobby. There's a very serious problem in Miss. -staff v. volunteers. We're trying to correct the staff problems by holding district meetings, COFO, FDP This should bring about an understanding of what is going on.

Ivanhoe: If we're not to ing to work with the FDP we should pull out of Miss. for the summer.

Chair: Let's talk about May 10th staff meeting.

Cleve: We plan to hold workshops on SCLC- speaker from this organization -- also programs, etc.

It should be held in the context of an institute.

Chair: I went ot talk about SNCC staff meetings. Concerning who can come and remain in the meeting.

Jim: We ought to establish who's responsible fro Call Committee to reestablish who may come to Staff meeting (coordinating committee) and enforce this.

Fay: The Call Committee should write people who are to come to this cortain meeting and make it explicit that they aren't to bring anyone that the meeting will be closed.

Foremon: One of the things you can do is call the people ho receive checks staff and put people such as Fay on the payroll. to resolve this problem.

Ivanhoe: We ought to have a staff list and a Freedom Voice list of all personnel.

Chair: Who is on the Call Committee? Foremon: Let's choose one.

Muriel: The call comm. will be responsible for finding a place for the meeting.

Chair: ho will take responsible of setting up program Foremon outlined.
Carol Merritt takes responsibility.

Bill Ware: Couldn't there be a small meeting set up between SCLC and SNCC to make plain our ideas and to make clear how we can work together?

Jim: Belafonte is concerned about the split between the two groups to m discuss openly our relationships on the 20th in Atlant. I've asked Silas and we need four other people. I feel this meeting should be held.

Staff Education - Carol Merritt

We sent out 100 questionaires to staff on what they would be interested in doing. (I received 30 back and most of them want to learn typing and reading and writing. A business school in Atlanta is coing to train persons (free of charge) for two weeks. The off of education has made available \$3500 for a staff workshop. Does anyone have any idea what kinds of program we should set up?

Jim: State Projects ought to have some sort of reference librarys so that people on staff will have their basic information on hand. The research Dept. can handle the overall research. I'd like to see an education program around "how to keep records". Each project should have a list of all registered voters, who in the community owns cars, how many Negroes and whites are h there in a district.

Staff should know how to do reseach in their areas.

Carol: I think some one should be assigned to work on education full time. Judy Walborn helps out now.

Marion: If there is anything to be done in the north on education I could probably handle it.

Foremon: What is the nature of prejudice?

What is Caste? What is a Chatto?

Maybe Marion could help you on questions and issues such as these. For instance, there is a new book out, "Dark Ghetto", which I really think we should discuss.

We should develope a staff dictionary. When we use a lot of terms only a few know what they mean. We should also go into terms such as the difference between tenant and sharecropper.

Tom: Should be workshop on Negro History.
Muriel: Dr. Elsie Levis should be gotten down hwere and she
jnows southern history backwards and forewards. Also, I would
like to see Carol make the first workshop strictly experimental.
I would also think the staff should learn to train staff.

Foremon: All of these workshops should be decentralized. This makes for better cohesion and unity.

Silas: "hat is the discipline on workstudy people? I want to know what procedure, for instance Gladys Freeman. If a person on work study doesn't work out on a project, what do you do about them.

Foremon: I think we have to make use of the local talent resource. For example, in Mont. we found some people with certain skills out of work. Also need to develope program dealing with jobs.

I think we should talk about staff rotation. People get stagnant in the same place. But also in terms of rewards - very few in SNCC- one we have is new experience.

Carol: office/field experience important too (rotation).

Tom: What about apprenticeship type programs, partly rotating but working along with skilled persons.

Marion: Should start thinking about program for rotation involving northern offices. Think Carol and Betty should work together on this.

Ivan: Agrees if it is a coordinated program and doesn't allow people to drop in at randum.

Foremon: Ivanhoe has a report. I think we should hear it.

Carol: One more education point. Scholarship program - 30-35 people on scholarship. At least 8 people have left school after a semester or less. Don't get money back from school. Also, we don't (or haven't gotten the letterswere sent out) get the expense money back. William Porter and Sandy Stovall fall into this category.

Muriel: Talked to Charlie; we have scholarships to schools we can't readjust to - Negro Middle Class, etc. Want to raise validity of whole scholarship program.

Foremon: Person in education has to talk to staff people 1) about request for funds and 2) possibility of going to scholwhile raising question of responsibility to stick out the semester in terms of saving the money. Tom: Sometimes people drop out because they get caught up. Do we require information about grades? Why does it make a difference? Ruby: Yes, because people who consistently don't make school into a good experience shouldn't be able to come again and again for money. Marion: Some basic academic skills are necessary. Think Carol should find a way to encorage people to go back to school. Carol: Students who drop out are southern Negroes who got to southern schools. Maybe it was because they were close to the crux of the problem. The ones who attend Northern schools seem to remain in school. Foremon: I think we should start thinking below the college level. There are many who can get skill without going to college, even if we have to set it up ourselves. Muriel: I maintain that we keep the scholarship program. Foremon: The nature of SNCC has to change and we have to realize this. We ahve to broaden our ideas and ways of thinking. POSITONS ----Marion: Oppose the HUAC investigation of the KKK Staff: Why Stokeley: You oppose the HUAC because it is unAmerican. Ivanhoe is going to write up a report on why we oppse HUAC. Viet Nam --Silas: Logical extension of American Imperialism.

John: We have to take a position on the March to End the War in Viet Nam. Consensus that we endorse the march. We have people taking an active part in the march and we have helped get students (from the south) for it. John: We have to take a positon on Viet Nam also. America should withdraw. Staff: We just state to the press that we support SDS fully in their march on April 17, 1965. Marion: Have Ivanhoe and John Lewis draw up a statement for he press. Red-baiting John: Sometimes we leave ourselves too open by the company we keep. Ivan: I think we should be very naive on this issue. I think we should come with a very simple statement based on the first amendment. How do you answer a reporter if he asks you are there Communists in SNCC? Stokeley: John Doar gave the best answer I've heard of. He said that "Communists ususally pick out the problems in a country and work around that issue. The problems that caused the C.R. movement to begin is one of those problems. Therfore, they try to work in the movement (groups). Now if anyone wants to get rid of the Communists in the C.R. movement then everyone should work as hard as hell to rid the country of the problems that caused the movement to begin."

Stokeley: 1. We stand on the 1st amendment.

2. The country thinks we're a bunch of naive kids who don't know what they're doing. Now we should take advantage of this and be naive about the subject.

Ivanhoe: -- REPORT

I felt that we didn't know what communists were. We can take a very naive position. If you mean totalitarianism, this is impossible because we believe and work for democracy. Our programs stand high in speaking for what we believe in.

Silas: It seems to me that the last 6 months I have been coming to meeting, everyone always leaves before we get around to discussing programs. I'm roing to go back to Ala. and when we have the Ala. staff meeting, we'll make up our programs and just carry themo out.

Stokeley: I'm afraid that after I've organized Lowdes County, what will I do after this. So they're organized and the local register greets the with "we're going to register you" type stuff. When people were laughing and talking while Featherstone was saying we should organize around "One Vote and 3 Squares" that it really made me angry. Ralph really had a good issue but no one listened to that. It was too abstract to work on within the framework in which we're now existing.

Silas: A lot of the stuff we're talkong about now is going to be lost or ignored by the staff because there is no one here to carry it back to the different areas. Now for t instance the Hammermill Boycott, we stated that we would endorse it and the statemen ts were released to thet effect. It turned out that the Ala. staff and SCLC staff didn't do this. They (SCLC) planned the boycott outside of the state and we know about it.

Ivanhoe: That is partially my fault because Betty Garman did atted the planning committee meeting on the boycott with SCLC and a report was never sent to you.
