TMPORTANT INTERVIEW A five - member committee chair-

ed by the Reverend Ernest Bradford visited the superintendents of Dallas County and Selma schools. It is reported that Mr. Frank Ernest of the County school system did not answer any of the questions asked by the committee of concerned citizens. The committee included two ministers and three mothers whose children are in County & Selma schools. ... The superintendent is to make arrangements for a meeting of the committee with the Board of Education.

The committee was cordially received by the Selma school superintendent, J. A. Pickard. Mr. Pickard explained in a helpful manner the "freedom of choice" plan. The Selma system is to integrate grades 1-4. The committee expressed concern about the self-perpetuating Board of Educa-tion and asked if a current vacancy is to be filled by a Negro. The superintendent explained that the post has been filled and that the new member is not a Negro. The Board of Education is entirely white and controls a school system in a community, half of whose population is Negro

It was made clear to the superintendent that there is a decided inequality in the amount of facilities available and in use for children in the two high schools of the city.
