MANDATES TO SPECIFIC INDIVIDUALS

(including implementation of resolutions adopted)

I. TO THE SECRETARIAT

- The Secretariat is mandated to meet to review the actions of the Central Committee and discuss unfinished business at the end of each meeting.
- b. The secretariat is mandated to present a unified report on the state of theorganization at the beginning of each Central Committee meeting. The report is to be presented first berbally, then in writing, and is to include specific recommendations to the Committee, requests for action, and the reasons for recommendations and requests.
- c. The Secretariat is mandated to present a breakdown of county by county existing programs, and additional specific recommendations on the Alabama project. The report is to be in writing.
- d. The Secretariat is requested to present an assessment of our existing programs within the context of developing an national Black Panther Party and with particular emphasis on the 1966, 1967 and 1968 elections (especially in Alabama and Mississippi).

2. TO THE EXECUTIVE SECRETARY

- a. The Executive Secretary is responsible for the minutes of the Central Committee meetings.
- b/ The Executive Secretary is mandated to seek a campus coordinator to work with the program secretary as soon as possible. Suggested names: Jean Wiley, George Ware, Willie Ricks, Timmy McGraw. This is to be done as soon aspossible.
