

Neshoba Trials

An all-white jury said that 7 men of the 18 on trial are guilty of conspiracy against 3 civil rights workers killed in Neshoba County in 1964. The jury said 8 others were innocent, including Neshoba Sheriff Lawrence Rainey and the man on whose land the bodies were found.

Three others are supposed to have new trials, because the jury could not agree whether they were guilty. They include the man just elected sheriff of Neshoba County and a Baptist preacher.

Deputy Sheriff Cecil Price was one of two men found guilty who were not allowed to go free on \$5,000 bond. Judge Harold Cox said Price and A.W. Roberts made comments Thursday in the courthouse trying to intimidate the court and threaten the jury. They will be held in the Hinds County jail until Cox announces the sentences of the 7 next Friday. Cox said he was not going to let any wild men loose.

A Mississippi Klan leader, Sam Bowers, was also found guilty. He has also been accused of helping kill Vernon Dahmer in Hattiesburg.

→ A civil rights worker in Holmes County, Edgar Love, of F.D.P., was threatened Monday in Tchula by 2 white men, on carrying a shotgun.

Love drew a pistol in defense against the shotgun and called the sheriff from a nearby store. The sheriff arrived an hour and 10 minutes later. Love was arrested for having a concealed weapon. He has filed a suit against the town marshal, constable, and sheriff for not protecting him and for false arrest. The store owner has also sworn out warrants against several men for threatening him and damaging his property.

FDP Sues Eastland

The Freedom Democratic Party and the National Conference for New Politics have filed a suit in federal court against Senator James Eastland and others on a Senate committee.

The suit says that Eastland was responsible for the stealing of letters from the New Politics convention office in Chicago. Eastland later read the letters in Congress and accused the FDP and N.C.N.P. of being "Communist." FDP says the letters were used to hurt the campaigns of Negroes running for office in Mississippi on November 7. The suit also said that letters were turned over to terrorist organizations in Mississippi so that FDP supporters would be known and could be threatened.

"END the WAR Now"

Thousands of people across the country have been demonstrating this week against the War in Vietnam. The biggest protest is scheduled for the Pentagon (war headquarters) in Washington Saturday through Monday.

Although troops are being sent in to "control violence" expected in Washington, TV pictures have so far showed violence by police, like pulling sit-ins out by their hair.

The following poem was written about the death of Ernesto "Che" Guevara, South American freedom fighter, who died about two weeks ago. The government of Cuba, where he was a leader in the revolution, now believes that Che is really dead. Cuba will have 30 days of official mourning for him.

At an executive committee meeting last Saturday, the Mississippi Freedom Democratic Party to try to put out its newsletter twice a month. The October 1st issue was mailed out over a week ago to Miss. people who get the FIS Newsletter. About 2,500 copies were printed of the first issue. FDP hopes to print about 6,000 of the second issue. Executive Committee members will be asked to collect monthly contributions to pay the costs, and also each county group is asked to contribute. Joseph Harris is editor.

PROJECT MARK

Go into most any hospital. Who are the maids and janitors? Then who are the technicians, administrators, and nursing staff? Want to do something about it? Contact Medical Action for Research and Knowledge (MARK). Look around the streets, pool halls, cafes. Find a lot of young men and women 18-22 with nothing to do? Think that's bad? Contact MARK.

MARK has gotten money from the U.S. Department of Labor to find, counsel, and get into MDTA training 100 young men and women 18-22 for jobs related to medical care, such as Dental Assistant, Ward Clerk, Surgical Technician, Licensed Practical Nurse, Laboratory Assistant, etc. Trainees get paid while they learn and jobs after they graduate.

YOU can help by getting men and women 18-22, who have gone at least through the 10th grade, to fill out applications like the one enclosed with the Newsletter. You can get more copies of the application from MARK and then send them in filled out to Project MARK, Room 6, 1072 Lynch Street, Jackson, Mississippi 39203.

- fight to get our Board to borrow state money by selling BAWI bonds to buy sites for industry. Industries getting this deal must pledge to hire Black people on a 50-50 basis.
- fight to appoint a Black person to the County Welfare Board.
- fight to get our board to provide free food stamps for people who need them.
