THE REGISTRATION TO VOTE CAMPAIGN IS PICKING UP NEW INTEREST, DESPITE THE ATTACKS BY THE WHITE CITIZENS COUN-CIL AND THE COAHOMA COUNTY CHAMBER OF COMMERCE. THE ATTACK BY THE WHITE CITIZENS COUNCIL IS UNDERSTANDABLE. BUT ONLY THOSE OF US WHO WERE IN ON THE CONVERSATION WITH THE CHAMBER OF COMMERCE RELATIVE TO THE BANNING OF THE HIGGINS HIGH SCHOOL AND COAHOMA JR. COLLEGE BANDS FROM THE CHRISTMAS PARADE, WERE NOT SURPRISED BY THIS ACTION. WHEN THE COAHOMA COUNTY CHAMBER OF COMMERCE FOLLOWS IN E WHITE CITIZENS COUNCIL IN SUGGESTING TH AT THE REGISTRATION OF NEGROES TO VOTE WILL BE DETREMENTAL to the family. the business and the property of the citizens of Clarksdale WE ARE COM-PELLED TO SAY SOMETHING MORE TO BE DESIRED IN THE COAHOMA COUNTY CHAMBER OF COMMERCE. THE LOCAL COMMUNITY HAS NOTHING TO FEAR BECAUSE THE NEGROES ARE BECOMING REGISTERED TO VOTE. IT IS OUR AIM TO HELP PRODUCE A BETTER COMMUNITY WITH BETTER OFFICIALS, BETTER BUSINESSES, MORE EMPLOYMENT, JUS-TICE IN THE COURTS; AND COURTEOUS TREATMENT, IN FACT THE BELOVED COMMUNITY, WHERE THE WICKED CEASE FROM TROUBLING AND THE WEARY WILL BE AT REST. WHILE NOT SHOPPING IN DOWNTOWN CLARKSDALE UNTIL WE ARE TREATED COURTEOUSLY AND EMPLOYED ABOVE THE MENIAL LEVEL AND ALSO BECOMING REGISTERED VOTERS THERE ARE THREE MEETINGS PLANNED IN THE IMMEDIATE FUTURE THAT WILL BE VERY MEANINGFUL TO US. BE SURE TO ATTEND:

WE ARE COUNTING ON A GOOD MEETING WITH HIM THIS TIME, KEEP THE DATE IN MIND AND BE PRESENT. THE PLACE WILL BE ANNOUNCED NEXT WEEK.

MONDAY FEBRUARY 11TH 1963, IS "DICK GFEGORY" DAY. ON THIS DAY THIS TRUE AMERICAN WILL DO HIS BIT TOW RD EASING THE HUNGER AND COLD SUFFERED BY SO MANY NEGROES IN THE DELTA AREA. DICK, WILL FLY INTO MEMPHIS ON MONDAY WITH 6 TO 8 TONS OF FOOD TO BE DISTRIBUTED IN THE DELTA AREA TO THE NEEDY PEOPLE. MOST OF THE FOOD COMING IS EARMARKED FOR LEFLORE AND SUNFLOWER COUNTIES. LEFLORE COUNTY HAS NO SURPLUS FOOD PROGRAM AND THE PROGRAM IN SUNFLOWER COUNTY IS FAR FROM ADEQUATE. MANY PEOPLE IN COAHOMA COUNTY WHO ARE IN NEED ARE UNABLE TO SECURE ENOUGH FOOD TO SUSTAIN THEM. THE SUPPLY IS NOT NEARLY ENOUGH FOR THE THE NEED IS MADE MORE EVIDENT THIS YEAR BECAUSE OF THE EARLY GATHERING OF THE COTTON CROPS. MOST OF THE GATHERING WAS DONE FROM NOVEMBER OF 1962 TO MAY OF 1963, MANY NEGROES WILL BY MCCHINE. HAVE NO OPPORTUNITY TO WORK AND EARN ONE DOLLAR. THE EMERGENCY WELFARE AND RELIEF PROGRAM THIS YEAR IS AT BEST STOP-GAP. SOME LONG RANGE ACTION MUST BE TAKEN, NOW, TO PREVENT THIS KIND OF POVERTY FROM RECUENING YEAR AFTER YEAR. The Clarksdale Police Department has the task of explaining the death of a Negro Prisoner in the City Hall. The attitudes and actions, by both the Clarksdale Police Department and the City Administration, against Negroes all along, makes a thorough investigation in this death necessary by both Local and Federal Authorities.

It appears the most sure remedy to this kind of treatment is a sustained "Registration to Vote Drive." We must be willing to go, time and time again, to the Circuit Clerk's office and offer to register, regardless of how many times we are denied the right to register; most of our problems can be cleared up with the vote.

We can vote for decent treatment of Negro Prisoners by voting for a Mayor and City Commissioners that will not tolerate abuse of Prisoners. The Chief of Police and all other policemen are employees of the City Administration. We can vote for better and fair law enforcement by voting in men and women who will administer the law fairly without regard to race or creed.

We can vote for employment by voting into office and administration those that will secure industry which will employ all of the unemployed and not just industry that will employ the white unemployed.

We can vote for a better school system - one that will obey the law of the nation - by voting in a city administration that will respect the law of the nation. We can vote for better streets and lights in Negro neighborhoods by voting in men that can be fair in their administration if the popular vote will support them.

We can vote for the right to vote by supporting men who will not make it so difficult for Negroes to become registered voters. The vote will help tremendously in our struggle to gain dignity, respect, and employment from the downtown merchants. In the meantime we must reply on the boycott. Let us plan now to wear our old clothes for Easter. Those items we cannot do without, let us purchase them on this side of the railroad tract or go into other communities to purchase them. The NAACP is still supplying transportation to Memphis, Helena, Arkansas, and other cities where more courtesy and employment are available to Negroes. Under no circumstances should we trade at:

The vote will alos, in time, help the local press refrain from its continued discourtesy in refusing to refer, in print, to adult Negroes with courtesy titles. The personnell of the local press is really sympathetic to our cause for freedom. They disagree with many of our methods, which is understandable, none of them being Negroes. Negroes are unable to secure employment in many instances, seriously hampered when trying to become a registered voter, victims of an inferior educational system, victims of injustice in the courts, victims of police brutality, and victims of a status quo environment that points the accusing finger of inferiority and scorn to the Negor every where as a group. What is the one right method that will over come all of these difficulties? You name it - we will try it, notwithstanding the charge of publicity seekers.

The Negro is not without fault in this whole affair. Citizenship schools have been set up to help the Negro improve himself in every facet of livelihood. These schools are under the direction of Mrs. Vera M. Pigee, and are held every Monday and Tuesday Night, from 6:00 - 8:00 p.m. The schools are conducted at: Chapel Hill Baptist Church, Rayford Chapel Baptist Church, Silent Grove Baptist Church, Pigee's Beauty Salon, and Johnson's Sandwich Shop. All citizens are invited and encouraged to attend these schools to effect self betterment in every facet of life.

THE PEACEFUL PROTEST OF FREEDOM LOVING CHRISTIANS AND JEWS ALL OVER THE NATION HAS RESULTED IN RESTORING THE PROGRAM OF DISTRIBUTING FEDERAL SURPLUS FOOD TO THE NEEDY PEOPLE OF COMMUNITIES. THE CRY IS RAISED BY SOME OF OUR WHITE BROTHERS AND SISTERS THAT MOST OF THESE PEOPLE WHO RECEIVE THE FOOD ARE NEGROES. AS LONG AS JOB OPPORTUNITIES ARE DENIED NEGROES, AS LONG AS A POLITICAL SITUATION THAT THE NEEDS OF NEGROES ARE OF INTEREST TO THE POLITICIAN IN TERMS OF VOTES, NEGROES ARE GOING TO CONTINUE TO MAKE UP THE GREATER PERCENTAGE OF WELFARE ROLES. HOW MANY NEGROES ARE EMPLOYED IN INDUSTRY IN GREENWOOD, MISSISSIPPI?

GREENWOOD, MISSISSIPPI LOST ONE OF ITS BEST FRIENDS IN THE FEDERAL GOVERNMENT LAST WEEK WHEN IT ARRESTED ATTORNEY CHESTER RELYEA. IT WAS MR. RELYEA WHO, AT A PREVIOUS CIVIL RIGHTS COMMITTEE MEETING, HAD GIVEN THE ANSWER TO ALRON E. HENRY, PRESIDENT OF THE MISSISSIPPI NAACP THAT: "OUR INVESTIGATION INTO THE SURPLUS FOOD PROGRAM IN GREENWOOD HAS PRODUCED NO OFFICIALS THAT SAY THEY CUT THE FOOD PROGRAM BECAUSE OF REGISTRATION TO VOTE ACTIVITY." HENRY'S ANSWER TO THIS TO MR. RELYEA, WAS "DO YOU EXPECT THEM TO ADMIT IT?" THIS REMARK BY MR, RELYEA HAS BEEN PICKED UP AND QUOTED OUT OF CONTEX BY NEWSPAPERS AS SUPPORT FOR THE GREENWOOD PEOPLE. SOMEBODY IN GREENWOOD PULLED A BOO BOO.

THE NAACP MADE A \$1,000,00 CONTRIBUTION TO THE EMREGENCY WELFARE AND FELIEF PROGRAM OF THE COUNCIL OF FEDERATED CRGANIZATIONS, AND IS SENDING ITS ASSISTANT TO THE NATIONAL EXECUTIVE SECRETARY TO MAKE A SURVEY OF THE DELTA AREA. DR. JOHN MORSELL, THE EXECUTIVE ASSISTANT, WILL MAKE A PERSONAL APPEARANCE IN GREENWOOD, MISSISSIPPI, MONDAY NIGHT, MARCH 25, 1963 AT THE TURNER CHAPEL A. M. E. CHURCH. DR. MORSELL WILL FOLLOW BISHOP CHARLES F. GOLDEN OF THE METHODIST CHURCH. SPEAKERS TO FOLLOW DR. JOHN MORSELL INCLUDE: DR. MARTIN L. KING, JR., CONGRESSMAN CHARLES C. DIGGS, AND OTHER EXECUTIVES OF NAACP, SCLC, CORE, AND SNCC. SNCC EXECUTIVE SECRETARY, JAMES FARMER, HAS BEEN A CONSTANT VISITOR TO THE GREENWOOD COMMUNITY SINCE THE SHOOTING OF JAMES TRAVIS.

THE VOTER REGISTRATION SUIT BROUGHT AGAINST THE CIRCUIT CLERK OF PANOLA COUNTY WILL APPEAR LIKE A TEA PARTY COMPARED TO THE PENDING SUIT AGAINST THE CIRCUIT CLERK OF COAHOMA COUNTY. MORE THAN A THOUSAND NECROES HAVE SIGNED AFFADAVITS COMPLAINING OF THEIR BEING DENIED THE RIGHT TO REGISTER IN COAHOMA COUNTY. WE HAVE TRIED TO CALL THIS CONDITION TO THE ATTENTION OF THE RESPONSIBLE WHITE COMMUNITY OVER THE PAST FEW YEARS. NO INTEREST HAS BEEN SHOWN IN THIS DEPRIVATION OF HUMAN RIGHTS. TOO BAD THE CIRCUIT CLERK OF COAHOMA COUNTY MUST GO THROUGH THIS ORDEAL WHEN AN ACTIVITY OF FAIRNESS TO ALL COULD HAVE PREVENTED IT. WE KNOW HE, THE CIRCUIT CLERK OF COAHOMA COUNTY, KNOWS HOW TO BE FAIR BECAUSE FOR SEVERAL YEARS HE WAS. WHAT HAS HAPPENED TO HIM IN THE LAST FEW YEARS IS ANYBODY'S GUESS.

WE WANT TO CLEARLY EXPRESS TO ALL OF THIS COMMUNITY, BOTH WHITE AND NEGRO, THE RIGHTS THAT WE SEEK, WE ARE GOING TO OBTAIN. THE FREEDOM THAT ALL MEN SHOULD ENJOY IS AVAILABLE TO US, AND WE ARE GOING TO OBTAIN THEM IN THE NEAR FUTURE. OUR METHODS WILL BE PEACEFUL AND LEGAL. OUR WHITE BROTHERS AND SISTERS NEED HAVE NO FEAR OF VENGANCE OR REPRISALS FOR THE CRIMES THAT HAVE BEEN HEAPED UPON US THRU THE YEARS. IT WILL BE OUR HONEST HOPE TO HELP DEMONSTRATE HOW TRUE DEMOCRACY WORKS. CHRISTIANITY WILL BE THE CORNER STONE OF THE COMING ERA THAT WILL INCLUDE THE NEGRO AS AN EQUAL PARTNER.

INCLUDED IN THIS NUMBER WILL BE MR. ROY WILKINS NAACP EXECUTIVE SECRETARY, MR. CLARENCE MITCHELL, DIRECTOR OF THE WASHINGTON BUREAU OF THE NAACP, AND MR. WILLIAM KUNTSLER, ATTORNEY FOR THE NATIONAL GHANDI SOCIETY. EXACT DATES OF APPEARENCES WILL BE MADE AS SOON AS COMMITTMENTS ARE FINAL.

SEVERAL CITIZENS, FROM CLARKSDALE, TESTIFIED BEFORE THE CIVIL RIGHTS COMMISSION ON WEDNESDAY. ALL THE PROBLEMS, WITH WHICH WE ARE CONFRONTED LOCALLY, WERE AIFED AND HELP PROMISED. THERE IS NO DOUBT THAT THE RIGHT TO VOTE, FOR ALL CITIZENS, WILL SOON BECOME A REALITY. WITH THE VOTE ALL OF OUR PROBLEMS CAN BE SOLVED. UNTIL THE RIGHT TO VOTE IS GUARENTEED WE FEEL IT NECESSARY TO TRY EVERY OTHER LEGAL APPROACH, AT OUR COMMAND, TO OBTAIN FREEDOM. WORD HAS COME FROM CITY HALL THAT A GREAT INCREASE IN FIREPOWER IS COMING IN CONSTANTLY. THIS INCREASED FIREPOWER INCLUDES SUB-MACHINE GUNS, STEEL HELMETS, AND AMMUNITION. JUST WHAT THIS MEANS WE DON'T KNOW BUT IF IT HAS ANY CONNECTION WITH THE NECROES DRIVE FOR COMPLETE FREEDOM. THEY MAY AS WELL SEND THEM BACK TO WHERE THEY CAME FROM, BECAUSE WE SEE THE IMAGE OF FREEDOM, AND WE WILL LET NOTHING OR NOBODY TURN US AROUND.

THE OMNIBUS DESECRATION SUIT FILED LAST WEEK IS A CASE IN POINT. WITH THIS LEGAL ACTION WE INTEND TO DO AWAY WITH SEGREGATION IN EVERY ASPECT OF PUBLIC LIFE. IT IS OUR AIM TO REMOVE THE LEGAL SANCTIONS AND LEGAL SECURITY NOW GIVEN SEGREGATION IN OUR QUEST FOR EQUALITY AND JUSTICE. THE ONLY REASON FOR THE CONTINUATION OF SEGREGATION, BY OUR WHITE BROTHERS AND SISTERS, IS THE PREPETUTATION OF INJUSTICE AND INEQUALITY.

PLEASE LET US CONTINUE TO SUPPORT THE COMPLETE BOYCOTT OF DOWNTOWN STORES AND MERCHANTS UNTIL DIGNITY AND EMPLOYMENT ARE ACCORDED US. THIS MEANS ALL DOWNTOWN STORES NOT JUST THE WORST ONES. THE NON-VIOLENCE RESISTENCE MOVEMENT, BEING EMPLOYED BY MEGROES EVEN WHEN THEY ARE ATTACKED BY WHITES, IS COMING UNDER HEAVY DISAGREEMENT BY MANY NEGROES LOCALLY AND THROUGH OUT THE NATION. THE NAACP HAS ALWAYS ADVOCATED A POLICY OF SELF-DEFENSE. WE WILL NEVER STRIKE THE FIRST VIOLENT BLOW. WE POINT OUT TO CUR WHITE ATTACKERS THAT IN THE FUTURE YOU CAN LOOK TO LOSE NOTHING BUT YOUR SWING; YOU ARE COING TO GET YOUR LICK RIGHT BACK. THE ROCK THROW-ING, SHOOTING, BOMBING, AND BEATINGS, BY WHITES AGAINST NEGROES, IN THIS COMMUNITY, WITHOUT RETALIATION, ARE O VER.

THE FACT THAT MRS. PIGEE IMMEDIATELY REPORTED THE ATTACK UPON HER BY THE ATTENDANT OF THE SERVICE STATION TO THE LOCAL AUTHORITIES AND HER ATTACKER HAS NOT TO THIS DAY BEEN ARRESTED NOR CHARGED WITH ANY CRIME, AND SHE, THE VICTIM OF HIS BEATINGS, HAS BEEN ARRESTED AND CHARGED WITH DISTURBING THE FEACE, IS RIDICULOUS. THE BEST WAY TO CORRECT THE INJUSTICE. SUFFERED AT THE HANDS OF THE LAW ENFORCEMENT OFFICERS, IS TO KEEP GOING TO THE CIRCUIT CLERKS OFFICE AND REGISTER, AND THEN GO TO THE CITY HALL AND REGISTER AND WHEN ELECTION TIME COMES, CLUAN OUT THE WHOLE GANG!!!!! AND ELECT MEN AND WOMEN WITH THE ABILITY TO BE TRULY THE REPRESENTATIVE OF AND GUARDIAN OF THE RIGHTS OF ALL THE PEOPLE.

WHEN MRS. PICEE CALLED MR. MOONEYHAN AND COMPLAINED, EVEN TO HIM, OF THE ABUSIVE TREATMENT SHE RECEIVED AT HIS STATION, SHE WAS INFORMED, THAT "HE DID NOT SOLICIT NOR CARE FOR NIGGER'S BUSINESS." HE OWNS BOTH THE MOONEYHAN'S LION SERVICE STATION AND THE D. X. SERVICE STATION ON 49 HIGHWAY. BOTH OF THESE STATIONS WERE ADDED TO THE BOYCOTT LIST AT THE MASS MEETING, WEDNESDAY NIGHT, APRIL 24, 1963.

IT MIGHT NOT BE A BAD IDEA TO LOOK AROUND FOR ALL NEGROES THAT ARE TRADING AT SERVICE STATIONS OPERATED BY WHITES THAT DO NOT PERMIT NEGRO LADIES TO USE THE LADIES REST ROOM. THIS IN ITSELF IS AN INDICATION THAT THEY DO NOT APPRECIATE OUR BUSINESS AS MUCH AS THEY DO THE OTHER PEOPLE, YET WE PAY THE SAME AMOUNT FOR GAS, OIL, AND ALL OTHER SERVICES. LET US SERIOUSLY CONSIDER TRADING ONLY AT THOSE SERVICE STATIONS THAT PERMIT NEGRO LADIES TO USE THE LADIES BEST ROOM. SUCH A STATION THAT COMES TO MIND, IMMEDIATELY, IS JUNIOR'S SHELL STATION AT 1205 FOURTH STREET. SERVICE STATIONS THAT DIRECT NEGRO MEN AND WOMEN TO THE SAME REST ROOM ARE NOT WORTHY OF OUR PATRONAGE EVEN IF SOME OF US STILL GIVE IT TO THEM. ANY TIME WE CAN AVOID THESE STATIONS, LET'S DO IT-WHAT YOU SAY?

G. Spottswood, THE TREASURER, Mr. Alfred Baker Lewis, AND THE FOLLOWING MEMBERS OF THE BOARD OF DIRECTORS: ATTORNEY MARGARETT BUSH WILSON, St. Louis, Missouri; DR. CLAUDE HUDSON, Los Angeles, California; DR. LEONARD BURNS, New Orleans, Louisiana; AND OUR OWN MR. C.R. DARDEN, Meridian, Mississippi; AND MR. MEDGAR EVERS AND MISS MARY COX, Jackson, Mississippi. THE PRESIDENT OF THE NAACP, THE CHAIRMAN OF THE BOARD, AND THE TREASURER, ALONG WITH THE MEMBERS OF THE BOARD OF DIRECTORS ARE ALL NATIONAL PERSONALITIES. BANQUET TICKETS ARE AVAILABLE NOW. THIS BEING OUT OF SCHOOL HURTS THE FREEDOM MOVEMENT AND LIFE IN THE FUTURE FOR EVERYONE, MOSTLY THE CHILDREN INVOLVED.

CITY ELECTION HELD JUNE STH????? WHAT DOES IT MEAN FOR THE FUTURE???

THE ELECTION OF MR. W. S. KINCRE FOR ANOTHER FOUR YEARS IS NOT NECESSARILY A BAD OMEN. YES, THIS MEANS ANOTHER FOUR YEARS OF SEVERE PRESSURE AGAINST THE NEGRO COMMUNITY. IT MEANS ANOTHER FOUR YEARS OF ABUSE BY CHIEF OF POLICE BEN COLLINS AND SEVERAL OTHER MEMBERS OF THE POLICE FORCE. THE LAST TRICK OF SOME MEMBERS OF THE POLICE FORCE IS TO HAVE PARKED CARS PUSHED INTO THE STREET AND THEN CALL THE WIESS WRECKER SERVICE TO PICK THEM UP, CHARGING THE OWNERS OF THE CAR WITH IMPROPER PARKING. WHAT KIND OF UNHOLY ALLIANCE EXIST BETWEEN WIESS AND THE POLICE DEPARTMENT? WE CALL UPON CITY JUDGE CONNELL TO MAKE THIS INVESTIGATION, AND PUT A HALT TO THESE INTIMINDATING "TRICKS".

FOUR MORE YEARS OF MAYOR KINCADE WILL SECURELY TIE THE NEGROES OF THIS COMMUNITY TOGETHER. HE WILL EXERT ENOUGH PRESSURE TO MAKE US ALL SEE WHY WE MUST BECOME REGISTERED VOTERS. HE IS CHARGED WITH CONTRIBUTING TO THE DELIQUENCY OF A MINOR. HE IS 18 SHE IS 16. LEGAL ACTION IS NOW AT WORK TO CORRECT THIS MISCARRAGE OF JUSTICE.

YOUNG DEMOCRATS MUST GET TOGETHER

THE CONDUCT OF SOME OF THE PARTICIPANTS IN THE YOUNG DEMOCRATS CONVENTION HELD IN JACKSON LAST WEEK WAS DEPLORABLE. THIS IS NO WAY TO BUILD A POLITICAL ORGANIZATION. LET US TRY AGAIN TO MAKE THIS ORGANIZATION WORK. IT CAN BE A MODEL FOR DEMOCRATIC ACTION THROUGHOUT THE STATE.

VIOLENCE AND INTIMINDATION ON UPSWING IN MISSISSIPPI

WHILE GOVERNOR JOHNSON TALKS WITH TONGUE IN CHEEK ABOUT LAW AND ORDER THE POLICE, THE HIGHWAY PATROL AND SHERIFF'S OFFICERS TOGHTHER WITH THE UNNAMED REDNECK AND WHITE CITIZEN COUNCIL ELEMENT GO ABOUT THEIR DAILY BUSINESS OF "KEEPING THE NEGROES IN THEIR PLACES". BEATINGS, SHOOTINGS, CUSSING OUT, AND INTIMINDATION IN GENERAL HAS COME WITH THE NEW VOTERS RIGHTS LAW. THIS IS WHITE MISSISSIPPI'S ANSWER TO THE NEW LAW. WHILE PRESIDENT JOHNSON AND ATTORNEY GENERAL KATZENBACH ARE INFORMED DAILY OF THESE ABUSES, STILL NOTHING HAPPENS. THAT IS EXCEPT REV. DONALD THOMPSON IS SHOT DOWN IN JACKSON, MISS. AND MR. GEORGE METCALF OF NATCHEZ, MISS. THE PRESIDENT OF THE NAACP BRANCH THEIR IS BLOWN UP IN HIS AUTOMOBILE AS SOME LOW DOWN STINKING WHITE SCUM HAD PLACED A BOMB IN THE CAR TO GO OFF WHEN HE TURNED ON THE SWITCH. IN MANY SECTIONS THE KU KLUX KLAN AND THE WHITE CITIZENS COUNCIL ARE IN CONTROL IN MISS. NO OTHER LAW PREVAILS. MARTIAL LAW IS NEEDED, NO W.

SCHOOL CHILDREN LIVING WITH PERSONS OTHER THAN THEIR PARENTS

BECAUSE WE FEEL THIS LAW REQUIRING CHILDREN LIVING WITH FOSTER PARENTS TO PAY \$25.00 PER MONTH TO GO TO THE PUBLIC SCHOOLS IN MISSISSIPPI IS CLEARLY AN AFFRONT TO THE NEGRO COMMUNITY AND IS UNCONSTITUTIONAL, WE ARE INVITING ALL THE PARENTS INVOLVED AND THE CHILDREN TO MEET WITH OUR LAWYERS ON FRIDAY NIGHT AT HAVEN METHODIST CHURCH AT 8PM. SEPT 3RD. ADVISE AS TO HOW TO HANDLE THIS PROBLEM WILL BE AVAILABLE. BE SURE TO BE PRESENT. IN THE MEANTIME CARRY THE CHILDLEN TO SCHOOL DAILY.

FEDERAL JUDGE CLAYTON CONTINUES TO PERMIT SEGREGATION IN CLARKSDALE SCHOOLS.

BY ACCEPTING THE ZONING LINES SUPPLIED BY THE CLARKSDALE SCHOOL BOARD JUDGE CLAYTON BECAME A PARTICIPANTR IN CONTINUING SEGREGATION IN THE CLARKSDALE PUBLIC SCHOOLS. WE NOW CALL UPON THE DEPARTMENT OF HEALTH EDUCATION AND WELFARE AND MR. FRANCIS KEPPEL IN PARTICULAR TO WITHHOLD TO THE CLARKSDALE SCHOOL SYSTEM UNTIL IT DESEGREGATES IN FACT.
