The realtors' initiative against fair housing may be on the June primary election ballot. CORE is therefore conducting Voter Registration Workshops to educate and inform the citizenry about the dangers presented by this proposed segregation amendment. The endeavor is being made to coordinate the work of all groups interested in this very critical matter. Workshops will be held on THURSDAY, March 12th, from 1 to 4 pm; FRIDAY, March 13th, from 7 to 10 pm; and SATURDAY, March 14th, from 1 to 4 pm. General Membership Meeting of 27th February. It was announced that Leo Mouton has been appointed acting Legislative Action Committee Chairman; and that people are needed who can help with preparations for the Easter Saturday March for Peace, Freedom and Jobs. March will assemble at 12:30 PM, Saturday, March 28th, at the Sports Arena, and proceed to South Park for the program.

It was decided that Student CORE should demonstrate on Thursday, 5th March, at the Board of Education, to remind Board Members that they are still failing to solve the problems of de facto school segregation in Los Angeles. An extremely well-conducted demonstration took place as scheduled.

By way of encouraging an increased participation in the civil rights movement on the part of the clergy, it was decided that CORE should support the forthcoming luncheon meeting at the Victory Baptist Church, as well as the negotiations now in progress between a group of Negro clergymen and certain Huntington Park businessmen.

Members were urged to take part in Operation Jericho's current activities in Imperial Court, in Watts. Interested members should come to the CORE office by noon on Saturdays and/or Sundays.

The Employment Committee recommended an action against Packard Bell because of discrimination in upgrading. The action was voted, and is to begin in the near future. Successful negotiations with Milani Foods were reported, as well as progress in the motion picture and broadcast communications industries projects. These successes will result in the opening of many new jobs to minority group people.

The Membership Committee introduced two new active members. The meeting then proceeded to consider the Membership Committee's recommendation that seventeen active members of Los Angeles CORE be returned to member-on-approval status for breach of CORE discipline. After due consideration the following members were returned to member-on-approval status: Arnold Williams, Robert Hall, Richard Thomson, Mari Goldman, Bruce Hartford, Martin Goldsmith, F. Daniel Gray, Annette Becker, Woodrow Coleman, and Jerry Farber.

Chet Duncan, Western Regional Field Secretary, was introduced by the Chairman and made a very stirring presentation of actions planned for the coming summer, including a special action at the Republican National Convention in San Francisco, and plans for a special task force concentration on Chicago. He also spoke of the excellent job of lobbying Father Samuel did in Washington, and announced that the Western Regional CORE Chapters Conference will be held in San Francisco on April 17-19.
