Southern News:

COFO, consisting of SNCC, CORE, NAACP and SCLC in Mississippi is setting up a two day meeting in Washington D.C. for June 9 & 10. A four-hour hearing is planned on June 9 with people from the Mississippi staff, citizens from Mississippi and constitutional lawyers who will discuss the need and correctness for federal protection of field workers this summer in Mississippi. Delegates will also visit their congressmen and hold a press conference. On June 10, COFO workers and representatives of the sponsoring civil rights organizations will attempt to meet with President Johnson to impress upon him the need for dramatic federal support.

One of the results of SNCC's voter registration drives are the campaigns by seven Southern Negroes for congressional seats. The seven are: Mrs. Victoria Gray is opposing Senator Stennis in the Mississippi primary; Mrs. Fannie Lou Hamer is running against Rep. Jamie Whitten in Mississippi; the Reverend John Erle Cameron will oppose Rep. William Colmer in Mississippi; James M. Houston is challenging Rep. John Williams; in Alabama Mrs. Amelia P. Boynton is opposing Rep. Kenneth Roberts; C.B. King will oppose Maston O'Neal in Georgia; and A.C. Cofield is running a write-in campaign for Congress in North Carolina, SNCC is conducting voter registration drives in each of the areas where a Negro candidate is running.
