In order to encourage, to develop and to maintain a systematic flow of communication on this campus, a COMMUNICATIONS CENTER has been created in Room 38 of the Education Building. This Center is an outgrowth of a committee established by the Convocation Planning group. The CENTER served a most useful function during those meetings, and it is believed that that function and others should be perpetuated.

THE COMMUNICATIONS CENTER will have two major thrusts. The first is the effort to coordinate, to gather and to distribute information disseminated by organizations, groups, departments and individuals. The second is the effort to facilitate communications among individuals, groups, organizations and departments of the college.

It is hoped that the CENTER will be granted a status of neutrality by all factions and individuals involved. By being involved with the CENTER faculty and students are not indicating support for any particular position, rather they are concerned only with providing what is considered to be a necessary function during a troubled time and a desirable service at all times.

The CENTER will attempt to gather information and to make it available to students, staff and faculty members.

The CENTER will do everything possible to check out rumors. In this, everyone can be helpful. We are asking everyone who has information which confirms or denies the accuracy of a rumor, we ask that they communicate with the center.

The CENTER will constantly have people available for discussion, for "instant therapy," and for responding to the feelings and to the needs of anyone who feels the need for such response and/or support.

The CENTER is also arranging off campus meeting places for individuals who want to share their ideas and their feelings with others. Many of these meeting will be in the homes of faculty members and of students, and the hope is that they will provide places for people to respond spontaneously to the tensions being generated on the campus and in the world of which our campus is but a part.

In response to student requests, we are attempting to maintain a liason with individual departments on the campus, and we are hopeful the departments will forward to us such information as they feel might be helpful to the students.

ANYONE WHO WOULD LIKE TO BE INVOLVED WITH THE COMMUNICATIONS CENTER IS ASKED TO DO SO. FACULTY, STAFF AND STUDENTS ARE ENCOURAGED TO JOIN THIS "ACT OF INTIMACY."

This information is from Mr. Bernstein, the AFT s lawyer. When the injunction against the AFT was granted it was in the form of a suit against the AFT, the 8 members of the negotiating team from AFT and from number 1 to number 2000 John Doe picketers. Yesterday the negotiating team and 25 members of AFT were served with Temporary Restraining Orders. The expectation is that if those members persist they will be served with show cause notices which require that they show cause in court why they should not be charged with contempt of court.

Students are liable for these notices only if they are picketing in the same line as the faculty. If you are served with a Temporary Restraing Order you must accept it. AFT reports that their lawyer will be unable to handle student cases connected with the injunction.

AFT Local 1928

AFT Local 1928 is a union formed of all graduate students performing academic work (TASs, GAEs, Readers, Lab Assistants, etc.). Their membership is now at 90 members according to Rider Cooey, President. They are on strike for the implementation of student demands and in support of AFT Local 1352.

ACADEMIC SENATE'S NEW POLICY FOR PASS/NO REPORT
This policy is instituted for the Fall Semester, 1968 only.
The Academic Senate passed a resolution on Friday, January 3 which allows a student the option of being ecaluated either according to the regular grading

system or according to the Pass/No Report system.

The option of Pass/No Report will do the following to the students' records:

Pass: (P) Satisfactory completion of the course towards any goal, such as graduation, completion of Major or Minor Credential, etc. Units completed on this basis will not be used in arriving at a grade point average.

No Report: (N.R.) Unisatisfactory completion of course. No units earned. But the N.R, is not used in computing the Grade Point Average. Once this option has been initiated by the student it is mandatory on the instructor.

Students wishing to take up toe Pass/No Report option must apply directly to the individual instructor in writing by 10:00 P.M. Monday, January 20, 1969.

The interest of the administration and faculty of this institution is in affording a full educational opportunity to all students. We are making every effort to secure orderly classes and to remain open to suggestion and change.

The re have been indications in the student newspaper, the public press, and elsewhere, that more disruptions are planned for San Francisco State College. Such disruptions are not leading to any progress on educational reforms.

A faculty meeting called before Thanksgiving to discuss the problems on campus was cancelled. Immediately after that fifty members petitioned for a meeting but that request was not met. The AFT will picket the Creative Arts Building during the meeting and urges other people who share their feelings to join their picket line, or at least refues to attend a "faculty" meeting in which the faculty has no voice.

We have moved to Education 26, and can be reached at 469-1100 or 469-1240; we are open from 9 AM til 5 PM, Monday through Friday, and can be reached other hours at 647-9287.

We are involved in 2 aspects of communications. The first and primary is interpersonal communication. Our work ranges from delivering urgent messages to people to cruns ling distraight parents whose children have been arrested; from having a warm room with coffee available on rainy days to comforting someone who has seen physical violence for the first time and has been shattered by the experience. We more or less function in this area as we are needed. We welcome anyone confused or upset about the situation on the campus to come down, have a cup of coffee and rap with us about what this all means to you as a person.

The second aspect involves information and the printed word. We produce each day a newsletter that contains all the data relevant to the strike that we can gather. Except where highly relevant, we exclude postition statements, political tyrades, etc; instead, our focus has been to put out facutal information (who has been arrested; where meetings are; information about grades, etc.) One of the things that grew out of this was our class attendance statistics. They will be continued this semester as soon as classes are stabelized enough to make the figures at all meaningful. As time and money permit, we also reproduce relevant literature from all factions; we reproduced thousands of pass/no report petitons, over 10,000 copeis of the 15 demands, and so forth.

Another aspect of this distributing information area makes us a sort of "San Francisco Switchboard".for State College. If you have a question about something relating to the strike, most of the time we can ither answer it, find out the answer, or tell you where you might find the answer. We runction as rumortrackers, so if you hear a rumor, let us know and we will do everything possible to check it out. Aslo, if you thing we should have some information we should have, please call. We invite anyone interested in our work to come down and see how we operate.

TWLF MEWS COMPERENCE

TWLF announced at a news conference today that an injunction has been filed in the Federal Court of Judge Ziropoli. The plaintiffs are Mason Wong and Patricia Woolman; defendants are Edwin Duerr and S.I. Hayskawa. The injunction orders the defendants to show cause why the student disciplinary hearings should not be enjoined.

Three main reasons for this action are that 1) The only evidence used in the hearings are police and newspaper reports (no eyewitness reports). 2) The regulations concerning freedom of assembly are very vague. 3) Due process is not being used.

Also reported at the press conference were some statistics about the hearings: 10 students who didn't show up for their hearings were summarily suspended; 2 were suspended as a result of hearings; and 2 received letters of reprimand. There were 2 acquitals.
