PROPOSAL MADE BY THE SAN DIEGO CAUCAS AND SUPPORTED BY THE SOUTHERN CALIFORNIA CADRES REPRESENTED AT THIS CONFERENCE

The Tyrell boycott in Southern California was organized in June when the folks from Long Beach MDM, El Toro MDM, Killeen Texas, Marine Corps Base 29 Palms, March AFB and San Diego PCS participated in a reigonal meeting held in San Bernadino. One of the actions resulting from this meeting was a joint movement Tyrell's on July 30th by Long Beach MDM and San Diego PCS at their respective stores. Military felks and civilians showed immediate support by their participation in the boycatt and some people even brought food for everyone on the picket lines. Tyrell's tactics were to ignore us and trying to outlast us by staying open 15 hours a day. At the end of August we began having dramatic readings of a Tyrell's sales manual we had obtained. Tyrell's began closing dawn when we appeared and reopening a few hours after we left. At this point, Tyrell's Massacre Blues was introduced. Tyrell's couldn't close fast enough in San Diego or Oceanside (Camp Pendleton). The Tyrell's reigonal manager tried to negotiate with us at the end of September. He agreed to meet our demands locally but refused to meet the national demands or to sign a statement of agreement to the demands. Shortly thereafter, 20 GI's were busted for blocking the sidewalk in front of Tyrell's. The bust involved general harassment and all charges were dropped.

we've been maintaining the boycott daily for four months. We Tension has developed to a high level retween the picketers and the Tyrel' people. We realize there are many problems involved with maintaining a picket line. However, upon consideration of the far reaching possibilities or more likely probabilities of this boycott it is our position that it should be continued <u>NATIONALLY</u>!!!!!!

Our reasons for taking this position are stated as follows:

A. We have excellent mass support.

B. A whole new field has been opened up for recruitment.

C. It offers a solid basis for political education pertaining to class struggle, Capitalism, Imperialism etc.,

D Due to the fact that Tyrell's is not part of the ruling class it cannot economically maintain opposition to a nationwide boycott of its stores.

E. It provides an outstanding basis for unified national actions

F. It offers an excellent opportunity to refute the mistaken idea that the working class has no power.

We propose that the boycott be carried out nationwide. Unless this is done, we will have no alternative but to terminate the boycott because we cannot stop Tyrell's by ourselves.
