Pled not guilty--trial set for Friday unless prosecution can't be ready/

Will have jury--Guyot doesn't know the girl (he was charged in connection with) but may have seen her around (this is Guyot's statement)--

sidelines/ her mother works for Sgt. Creel of Hattiesburg Police part-time.

girl was influencee by local white Minister in Hattiesburg to not participate

in demonstrations. Police picked her up last night at her home and she's held

in protective custody. This morning they put property bond of \$500 on her.

She cannot retain counsel--court must appoint counsel because she's juvenile (13yrs)

Her name is Barbara Ann Thomas

~~kkkkkkkk~~ Her mother has been working with the juvenile authorities about her for over a year (about her delinquency)- statements have been given about her character before the movement really got accelerated here-staying out til 2-3am, etc.
