JACKSON

- From Clarion-Ledger: A joint session of the state legislature may accept Parchman Penitentiary reform bill following a joint conference committee revision which deletes an amendment which would have banned use of the lash. If bill is accepted, it will be ready for gov's signature shortly.
- Rev. R.L.T.Smith's store door broken down tonight. This follows earlier breaking of store windows.
- NATCHEZ Bomb threat received at meeting of Miss. States Advisory Committee to U.S. CRC being held in Natchez post office. Hearing forced to vacate room and move. Reported that KKK-looking men tooks notes on those who testified.
- CANTON Bomb threats received at the office all day (e.g. 3 b/w 9-9:30) and known WCC people driving by. Eric Weinburger there to start sandle factory. Threats of burnings. Mateo Suarez in jail for illegal parking.
- GREENVILLE three Negroes admitted to Republican precinct meeting, treated cordially.
- LEXINGTON Mrs. Hazel Brannon Smith got Pulitizer Prize for "steadfast adherence to editorial duties" for her Lexington Advertiser. Also has weeklies in Durant, Flora and Jackson.

HOLLY SPRINGS - Alvin Packard (Negro) and Larry Rubin (white) in jail. No detail

- JACKSON from Robert Weil. Two new bills intro in state legis today. House bill 870 prohibits entry into state for purposes of willfully violating laws of the state. Makes it a felony to advocate change by force, violence, or willful violation of state laws, punishable by not more than \$1,000 or two years or both. Senate bill 2027 defines "criminal syndicalism," prohibits assemblege for c.s., provides penalty. Section I defines c.s. as any doctrine or precept which advocates or teaches the commission of crime, sabotage (defined as willful damage of physical property) unlawful acts of force or methods of terrorism wkiz as a means of "effecting change in agricultural or industrial ownership or control, or in effecting any political or social change" and includes the teaching, speaking, organizing of criminal syndicalism. Another section provides from one to ten years prison or \$200 to \$1000 fine or both
- for anyone present at a meeting advocating c.s. Another section makes it a felony to act as agent, janitor, superintendent for premises of an assembly dimeanor advocating such c.s.

GREENWOOD - from Sam Block, Bill Higgs, Hunter Morey et al

Confused case of Mrs. Lauara McGee whose nome and 58 acres have been involved since 1955 in foreclosure. Two Greenwood lawyers, Hammond and Odams apparently did not make proper payments for her after she had been sent to a mental hospital twice during course of foreclsoure litigation. In 1962 case taken by Higgs & Rosenthal in Jackson. Problems erupting again. She had deeded 6 acres to Higgs and Rosenthal a lawyer's fee when they stopped foreclesure in '62. Last night a bomb was thrown on her front porch. This morning men from sheriff's dept. had warrant for her arrest for trespassing. Case very confused. Hunetr Morey gathering I data. Derrick Bell OK'd Inc Fund to take case when she has to appear in justice of the peace court tomorrow, May 7. Warrant also issued for her invalid son, scheduled for operation in University Hospital tomorrow. The case is not unrelated to civil rights however. Her son Clarence Robinson McGee had several attempts at arrest made on him when he returned from army and tried to vote. Her borther, Charles Coates was in Belzoni when Rev. Lee was killed, has been a marked man since. The Delta Folk Festival last June was held at her farm. Prior to her retention of Higgs & Rosenthal, Odams had been retained. She had apparently been making payments to him' with the understanding that he was paying off her loan to the federal land grant bank, but when she was released from the hospital, found out he had not. Odams had been hired straighten out a similar mess with attorney Hammond.

JACKSON - from Rick Seifert A batch of unfused bombs was found in a vacant lot behind Brinkley high school (Negro.) tonight. No details.
