Philadelphia 10:00 p.m.: Contact press: are going to take group of Negroes to Court House tomorrow to attempt to register. There is an injunction against Cofo people to come to Court House ~~with~~ for number of weeks. They have not received copy of court order. Heard about it from very reliable sources. Sheriff told them could pick up the injunction from the judge but are not going to do it. Expect about 30. Sheriff has stated that anyone who comes will be arrested (Rainey). Will go at 10 a.m. Sheriff has not formally notified that courthouse closed, only informal word. Collier wd like JD and FBI notified, too.

McComb 11:25 Two bombings in the past 24 hour ...two children Mrs Kingman Aloysius Quim badly damaged, two child hildren 7yr old 4yr old boy, suscit Rd..... dynamite, .. badly damaged..... other house, just few minute south hill church W 51 So. has been used before ...1961 esp.....baptist... shooting now.... Mrs. Quim own retreat... movement since 1951.. Negro.... strong support.... much harass...last two weeks ... close to f-house...hearton south Moo....pastor Ned Taylor....church hold v-r classes majority of kids invooved with mvment use church.... time of first 10:50, second- 12:20 rest owned by white man, he got pressure, but relented; also bomb threats to her.

12:20 just got report that church in Beartown almost completely destroyed; burned t o to the ground. Call back in 15 minutes

12:35 Gone to Mrs. Quim's. A riot is going on at the Quim home. Staff id at scene. Harris wants Ned Conn. called and ask D r. Howard to go. My HF.. Jesse will be back soon. Claire called and will get Dr..(12:40).

Brown Reg. says no riot. Rather is on Highway. Quim need Med. treatment. RIOT. Kids were upset, shooting at cars and throwing bricks, ect.. Kids are injured. Police are at scene of other bombing. Dr. kids went to warn't in. Quim home busy. Bus y. Office phone is busy(?) Called Mr. Jane 604-5109 WHITE said send to hospital and he would see them.

Quim residence 1:03 Two children were sleeping in room where bomb was thrown. A lot of people there. Some threw bricks a policeman. Youngest child was cut on head, by blast, house torn up. Police car was bent as people left the scene. police got there 30 minutes later. House is 8 room home all but one has been damaged. Girl heard thud on porch, look, went to phone and the thing went off. Police left. Said too many people around..Bomb was seen by a girl that was staying there(see above) and was under edge of porch. Quims are calling Dr. Jane.

Atlanta : is in contact with JEs. Boar has been reached(not graft).

English : 1:15 office. Kibbys younger... Jackie is other, rather was next door. Baby sitter was one who saw bomb. Was police car. Damage: bricks and bottles. Will follow up on Med. bit. Ages on children 5 and 9. Jackie's birthday cake was on table in room where they are sleeping.

Greenwood: Stockley car hasn't checked in from Indiana, left there around 12:00. Mac Laurin, Harris. Possible Survey and nurse in Clarkdale also not checked in. (Called when Stockley first called at 12: 20. Had left Indiana, couldn't reach Clarkdale.) Stockley is whether they bother checking in when they arrived. Will Call at 1:40 to check.

McComb 1:40 Edwards Called from California. Said he would contact JEs tomorrow and try to get statement from the PRESIDENT. Know nothing about chaotic bombing. Harris then. Was at church last sunday. Spoke, asked to use church for V. S. Had been used during 1950 for similar activity. Had board of Meeting, talked to meeting and they agreed to let us use church. Monday they asked him to come back before the church and talk to cong.. Decided to wait until after election (cong). Most people that attend church are those who supported FDP and children attended FS.
