Mr. Kuenzly reporting on interview September 18 with B.F. Smith, executive v.p.,
Delta Council, Stoneville, Miss.
Delta Council is made up of plantation owners, business men and others; 18 counties;
Delta and part-delta . Organized in 1935; gave birth to the National Cotton
Council; Delta Council is the economic development organization for the delta.
They work on all phases, mainly agriculture. 11 people on the staff. Dept. of
industrial and community development; they have committees on health, education
flood control, etc. Since 1957, 76 new industries have been brought to the delta
as a result of their efforts; these industries employ 10,000 people; 25 % of which
are Negro. He pointed out that they have something to do with public law 78
which brought Mexicans and nationals to the delta. They didn't like the Mexicans
so this program was "stopped cold." In 1953, there were 2 1/2 million acres of cotton
grown in Mississippi; in 1963, there were 1 1/2 million acres . This is due to the
U.S. acreage control program. He said that 80% of the cotton in the delta is now
picked by machines. He said that cotton prices will have to be reduced to meet
competition of man made fibers. This will not necessarily mean a drop in wages
because they have programs for reducing insects, weeds, grass, and boll rot.
Through research they can correct these things and make savings. Jo was very
friendly, eager to talk. It seemed to Dr. K. that some negotiation could take
place with regard to jobs, wages, vocational training, and industrial development.
He said that there group does not want to make the delta an industrial belt, that
it is one of the richest agricultural regions in the country and they want to keep
it that way. Mr. Smith is an ardent segregationist when it comes to schools, but
he does not seem to be so ardent Negroes in the employment area.
