Philadelphia 7:40pm: Having a Freedom Day tomorrow. Handle the pr relations. (yes)

Ruleville 8:15pm: Larry King and Henry McCoy, MSU students from Ruleville, were given a ride home after meeting Sunday as far as Greenville. Someone from Ruleville was to pick them up and return them to Ruleville. Greenville does not answer their phone at 8:25 and an earlier call they had not heard of the boys. Boys have not returned to Ruleville.

Greenville 8:45pm: Larry King and Henry McCoy arrived Greenville 8:40 - late because of car trouble. Will stay overnight in Greenville - return Ruleville Monday morning. Ruleville notified.

Holly Springs 9:00..Ken Scudder...checked in for the rest of the year..NEW YORK.  
Milwaukee, Wis... is his home.

McComb: 9:00; 200 people attended ~~the~~ a mass meeting at the Society Hill Baptist church this afternoon. There were no incidents. Freedom day is called off until Oct. 26. Registrar is on the grand jury. There is no legal way to get a deputy Registrar. Tomorrow night, 7:30 another meeting will be held at St. Pauls Methodist Church.

GREENWOOD: 9:45; Bruce Maxwell expected at 6:00 in Greenwood from Talahatchie County. He's not there. Have tried to have Ruleville call them on their radio, but Talahatchie's radio is not working. Going to have someone from Ruleville go up by car to T. County and find out all the info that we need. There was none at Ruleville. We have since contacted Greenwood, and they have sent out 3 people to look for Bruce. Rev. Young, John Handy and Mr. James Moore.. Left about 10 minutes ago. For Tangle house....

12:30...We've been calling all the jails in the Talahatchie area..also all the police stations highway patrols, sheriff's offices and hospitals/.....

RULEVILLE: 1:30; Rev. Young, reported that Joe Louis Hail is in the Charleton Jail. Hail had been at a fair and talked to a white girl. He was arrested. The Sheriff said he would not let him out on bail because the white people would "kill him on sight." His brother John Hail, said that he spoke with Joe at the jail. Said he was not beaten. Rev. Young is going to go to the jail and check it out. Unconfirmed castration rumor.

Greenwood..Rev. Young..Went by the jail, no response returned to Greenwood safe and sound Borrowed \$2 from Mr. Homer, and \$4.66 from Greenwood, To be sent to Greenwood.

RULEVILLE: 8:00; Called jail in Charleton. Jailer says he is in jail, and "All I know is that he is just in jail." Could give no information on bond etc. referred to sheriff. Jailer's name is Collinger. Called Sheriff's office , 7:40, busy twice, and then no answer, about 2 minutes later. 8:00, the Sheriff's office, secretary could not give information. Said to call I.E. Degan, Deputy Sheriff. No I.E.Degan exists. Name is E.R. Degan. he'd talked to Sheriff's wife at 8:05. Referred to Deputy Sheriff E.R. Degan. He Said /looks at the files, sometime today, and that he didn't know anything about it.

Jackson ..9:00..The kids who were kicked out the other day passed out freedom buttons to the other kids in the school...approx 1,000 buttons. They did NOT wear their buttons. They went into the office to secure their permits to class. Buckley told them that they could not enter their classes until they bro't their parents back. Also he said that letters had been sent to their parents. Not allowed on the campus until they bring them back to school. They left. There was an announcement over the intercom that the teachers who ld make sure that the kids didn't wear the buttons in class. Presume that they took their buttons off.

MARKS: 9:30; Bail money for the four boys has not come yet. Allan Goodner is sick, and Klendike has been beaten in jail. They are still trying to make him change his story.

Philadelphia: At 10:00, Collier; They have 50 people for Freedom Day. They're going down in a few minutes--they're getting ready now.

-Greenwood - Request for Doctor by Rev. Young attempted to be coordinated by Jackson Medical-Committee. Med. may be needed by Hail in Charleton. Calls to Greenwood by Jackson COFO to Ruleville and Greenwood for drivers of any doctor who may go. Rev. Young is going up to Charleton to check on Hail. Plans to leave about 11:30. Rumor relayed to Tallshatchie COFO by Sam Hampton, working as staff. (Detroit?) According to reports the Sheriff's office is supposed to be holding him in protective custody. (Rev. Young) Rev. Young will carry a retainer to the parents of Hail for legal aid. Garrie Hall was-called and given (jail) the run around. Recommended calling the FBI. FBI called, Agent Pudister, (Wendy talked to) says that he will get on it.

BULLVILLE 1:30p: Rev. Young, reported that Joe Louis Hall is in the Charleton Jail. Hall has been at a fete and visited by a white girl. He was arrested. The Sheriff said he would not let him out on bail because the white people would kill him on sight." His brother, "the Hall," said that he spoke with Joe at the jail. Said he was not beaten. Rev. Young is going to go to the jail and check it out. Unconfirmed confirmation rumor.

Brenwood, Rev. Young, went by the jail, no response returned to Greenwood safe and sound. Received \$2 from Mr. Hauer, and \$1.56 from Greenwood, to be sent to Greenwood.

No T.R. Dugan exists. Name is M.M. Dugan. held Talked to Sheriff's wife at 8:05. Referred to Deputy Sheriff M.M. Dugan. No file filed in the files, sometime today, and that he didn't know anything about it.
