11:3000. Powell rearrested, although he had gotten out yesterday. They say they don't know his, he's not there. 3263111 jail. Police are looking for Klondike, according to his mother. it was J's mother who reported JD's arrest to Allen Jackson is to call them back at 1pm. Mother and father and Joe Bateman are going to the jail to find out what happened. The jail would not give info over the phone.

Fuleville 12:10PM Linda Davis read in the local paper that a special chapter of the Citizens' Council has been formed in Fuleville--"Fuleville Citizens' Council." Officers; Bill Lord, Pres.; DeWitt Jones, V.P.; E.P. Philadelphia : another imprisonment for debt - \$17.50 paid on \$18.50 debt. A justice summons. James Kenneth Pickens defendant. Alan Shiffman suggests making this a case. Hunter will try to get at this. The man out.

Alan Shiffman wants to know what about his bond forfeiture when his case was removed

Marks: J. D. Powell charged with tearing up mattress in jail, flux and with disturbing the peace. Deputy Faust wants Klondike Abbot to come down so he can also be charged with the same thing. Deputy Faust won't tell anyone anything to anyone till the parents of both appear with Abbot. The woman who was arrested earlier today only has the "charge" of trying to register to vote.

Marks, 2:20 - Joe Bateman - Bateman, Klondike's mother, J.D. Powell's step-father, Mr. Evans, and his mother went to the courthouse to see what the charges are against Klondike. Mrs. Evans & Klondike's mother went inside; others stayed outside. Deputy Faust told them that he would talk not talk to them without Klondike & refused to tell them his charges. J.D., in jail; Faust refuse to tell anything about Powell's charges or bail. Secret message from Powell says charges are ripping a mattress & disturbing peace etc. Would make it light on Lonnie (Klondike's brother) if Klondike came to jail - said police.

Greensboro: Stopped when crossing road construction, car stalled, was about to let us go and then asked who owned car, Ans. Mrs. Gray cop glanced down saw Gray bumper sticker and called someone for instruction. Sheriff and cops held conference and took Ted Jacqueney and finally decided to book him on reckless driving after another conference. Pushed him around because he insisted on calling Mrs Gray by Mrs. and not just Gray (officer involved was E. W. Palmertree-- Badge # 39 and W D Robinson #18) Ted now out.

Balsani ..Bill Ware has been arrested for distributing leaflets sans permit. In the Balsani Jail. Picked up at about 4:30 . Report came in at 5:10. Call the police dep't. at about 6:30. Balsani 307. Nobody there knew anything about anything. 5:35...3 more people have been arrested. Robert Bass, Ellis Jackson, Joe Louis Stigler. Wouldn't give Mathew either their charges or the jail that they are in.

Balsani: 6:25 Robert Bass called from jail. All four are in jail on criminal syndicalism. Bail not yet set, but probably \$1,000 (the previous cases were first set at \$1,000 then reduced to \$500. Atty. Rosenthal is going up tomorrow to get them out with \$2,000 sent by the Marquess fund). Trial is either 10am or 2pm this Monday, Oct. 19. They were merely walking down railroad st., which is downtown Negro section Balsani. There were several Negro young people around, but no disturbance. The police, in a car, stopped them and said that Captain Nicholson (spelling?) wanted to see them. They refused to get until told they were arrested. One of the officers was Abner Abels (sp?) Each defendant was carrying one FOP leaflet. They were not passing them out. Atty. Ben Smith is handling Neblett

Jackson: Grace and Anne Pearl Avery going to Hatches checked in for security. Plan to get to Hatches by about 8:45pm.

Tchula 9351 Mary Brunner. Wants Wandy to call her as to whether or not she has a band for them this St. night.

Tupelo : Emy Schrader's case is continued until Friday Nov. 6. at 1:30pm before J.P. Heggison. - Atty. Harry Kier.

Muske Nuleville : Ollie Young of Nuleville who testified at Cecil Campbell trial in Sunflower county is dead. He was reported drowned in Itta Bena, however there is a question of whether or not it was an accident. He was heard calling for help but no one saw him. The Klans were distributing newsletters today in the white section. Contact F.B.I.

Marks ... Mr. Kier on Daisy Campbell who was arrested for trying to register. One of the officers told her sister if she hadn't tried to register to vote she wouldn't be in so much trouble.

On the 3 who were just bailed out...Dep Sheriff Farnix Faus told Mrs. Cannon (the Abbot boys mother) that if Clendike would give himself up, James (who's being held in juvenile court) would have an easier time of it. Faus came over to the masonic hall but they would not let him in...searching for Clendike. because he didn't have a warrant. When Mr. Kier went over to the jail to bail the boys out, Faus showed him some masonic stuff which he said that Clendike had destroyed. A "Tom" prisoner verified this. The 3 boys denied this. Upon release but admitted singing Freedom and religious songs. Sheriff lives right next to the jail and was probably disturbed. Presume that they're after Clendike for this destruction of public property.

Greensboro: Atty. Rosenberg of the Justice Department called to say that the trial of U.S. v. City of Greensboro is postponed and that all people such as Bob Moses and Guyot are now not to come Monday to Greenville. We should know by the end of the week when it might be. Hunter reported the Balsani criminal syndicalism and Marks N. Campbell jail situations.

Atlanta 10:25 Bob Moses: Drew Pearson is going to bail out the 15 local people in M.Comb arrested last week for criminal syndicalism. H. is doing it, he says, for the sake of the dedication of his former secretary, Margaret , who is teaching literacy in Steenville (new volunteer as of 2 weeks ago). H. is sending

it directly to the sheriff. Bob and he thought this could turn into a revolving bail fund, working through the NAACP to get it back and get it revolving. McComb rejoicing!

News Margaret Laughrun's statement: "Why can't he be doing it for the people instead? This kind of thing has been going on a long time--why did he wait till now? Anyway, I'm glad they're getting out."

Jacksonwhile there was a freedom school meeting at Mt. Nebo, which is on a dead end street, a white Chrysler licence # H2951 drove up. It is on Tupelo St. It drove by several times and had 3 men in it. Before this a car with 2 white women drove up, made a U-turn and said some derogatory things.

TOHULA: Don Huser returned from an action group meeting in Lexington, was stopped by Highway Patrol outside of Lexington. Patrolman R.L. Needy asked to see Huser's license. He showed it to officer Needy. Needy told him to get in the police car and told the four other boys to get out and walk home. Huser is white. The other four are local Negroes. The car has been impounded, and Huser is in Lexington Jail. The Sheriff Smith says he knows nothing about it, however it was confirmed by jailers that he is in the jail. Highway Patrol do not know, the patrolman I spoke with said Needy would know, his charge that he could contact Needy by radio, but that he had no intention of doing that. Jail-er said, "He's in jail, but I didn't even know his name until you people called." He said that he could not tell me what his charges were, and that no one else could unless we came up there. Then he hung up. John Allen at Tohula COFO, said he would call Needy at 12:00. "He usually tells us." Which speaks well for Needy's business!

MARKS: 12:00; Mrs. Daisy Campbell has been released in her cousin's custody. Her trial is at 9:00. Told her not to come with any COFO workers. Charged with passing a Registrar. Tried to reach lawyers; they are asleep! They want Laurence Apsay to take the case. He is in Laurel. Don't know yet if he can be reached. J7977898YI;798878998887888 .39 Klendike is going to the country tonight. He'll return to Meric tomorrow for a mass meeting. Will probably be arrested Saturday, says Allan Goodner.

TOHULA: 12:30; Officer Needy reports that Huser was arrested for improper lights. Bail will be set in the morning. "He can get out in the morning." Said Officer MOODY.
