- 4. How many Congressismal Districts are there in Georgia 10, and in which one do you live? 3rd
- 5. What is the term of a United States Senator? Six years
- 6. What is the term of office of a State Senator? Two years
- 7. What is the county seat of your county? Americus
- 8. How may a new state be admitted to the Union? By act of Congress
- 9. Who are citizens of Georgia? All citizens of the United States who live in Georgia
- 10. How many votes does Georgia have in the Electoral College? Twelve
- 11. In what State Senatorial District do you live 14th and what are the names of the counties in such District? Terrell, Randolph, Sunter, Quitman, Stewart, Webster, Chattahoochee
- 12. What are the qualification of the Representatives in the Georgia House of Representatives? Citizen of the United States; 21 years of age: resident of county for one year.

- 20. How does the Constituion of the United States provide that it may be amended? Article V States: The Congress, whenever 2/3 of both houses shall deem it necessary shall propose amendments to this Constitution or on the application of the legislatures of 2/3 of the several states shall call a convention for proposing amendments, which in either case shall be valid to all intents and purposes, as part of this Constituion, when ratified by the legislatures of 3/4 of the several States or by Conventions in 3/4 thereof as the one or the other mode of ratification may be proposed by the Congress
- 21. If the Governor of Georgia dies who succeeds him and if both the Governor and the person who succeeds him dies, who exercises the executive power?

  The Lieutenant Governor. Speaker of the House of Representatives.
- 22. What does the Constitution of the United States provide regarding the suspension of the privilege of the writ of Habeas Corpus? Under the United States Constitution it can not be done "unless when in case of rebellion or invasion the public safety may require it. What does the Georgia Constitution provide? Under the Georgia Constitution it can not be done
- 23. What are the qualifications for jury service in Georgia? Name must be on the book of the County Tax Receiver, and upright, intelligent citizen.
