told them about the meeting at Leslie Lee King's house, and they said they would be there. Also - I deliverred mail from the F.D.P. I told them that from then on, mail would come to their address.

Went to Rev. Echols' House, and dropped off some mail, and a note telling about the meeting tomorrow. Echols was not home.

Picked up Mr. Gipson in Hudsonville, and drove to Robert's Chapel, above Mt. Pleasant, to go to a Christmas Party to which we had been invited.

No one showed up at the party except George Robinson, the sexton, and two or three others. Mr. Gipson and I discussed fund-raising for the Challange Trip ~~to~~ with Mr. Robinson. He was enthusiastic about raising money.

Came back to office. Got stoned.

Saturday, December 26

Leslie Lee King came to the office. He said that he could not have the meeting at his house because he had to drive his wife somewhere that evening. I sensed that he was not telling me the real reson for his not wanting it at his house.

Spent most of the afternoon canvassing in the Chulahoma area. I went to Rev. Echols, and he agreed to have the meeting at his home that nite.

I contacted Mr. Totten about the change in meeting ~~time~~ place. He said that Mr. King had told him that he, Mr. King, was afraid to have any meetings at his home because a white man had moved next door, and Mr. King ~~was~~ said he was afraid that the white man might get angry. I suspect that this is not the whole story. The white man ~~lives~~ lives down the road a long ways, and can not see who goes in and out of the King place. I suspect that King's fear comes from the fact that he is afraid his wife will loose her teaching job. I tried to contact King, to talk to him, and try to get him to tell me straight, but he was not home.

Got to the others who were expected at the meeting.

Went to see Walter Evans, in Holly Springs. He is chairman of the Marshall County F.D.P., but is totally ineffective. He says that he is too busy with school work at Rust College to do too much work. After much discussion, he finally agreed to drive his car to Washington. He agreed to come to the ~~meeting~~ at 6:30;.

Meeting at Echols: Walter Evans led. Present: Mr. Napoleon Totten, Mrs. Lorsie Jones, Rev. Echols, Mr. Vee Jones, Burnall Malone, and James Taylor.

Rev. Echols will tell me Wednesday whether or not he can go, and if he can get a car. Mr. Vee Jones is going. Mrs. Jones has raised about \$25 by going to churches and stopping people driving down the road in front of her house. Burnell and James are planning to have a dance at their high school to raise money. The principal has agreed to let them have one Tuesday night.

Things are going well on the Challenge.

Sunday, December 27, and Monday December 28

In Jackson with Kathy, U.Z., Howard, and Rita. Among other things, I spoke to Henry Aaronson, and explained I would be leaving Miss. after the 2nd. He agreed to come to Holly Springs Tuesday, to deal with my case.

Wednesday, December 30

Morning: sent mailing asking for money.

Picked up Pat Amlin and airport.

Went back to Olive Branch - man said he could not go.

Freedom School at St. Joseph's: We discussed the fact that I'll be leaving Saturday, and Barbara won't be back for a while. I said that based on the way the classes were going, the school could really function without workers at every meeting. The people agreed that they could handle the class and the library that is functioning there.

Pat Amlin was there, and she offered her services. Mrs. King, the ~~main~~ local person who mainly organized the class, said she felt that Pat was needed. Pat will work with the classes.

Two of the teen-agers were there that are going to Washington: Burnell Malone, and James Taylor. We left the meeting to try to get another kid to go, and to speak to Rev. Echols. I felt that it was good we left, to give Pat a chance to work alone.

Rev. Echols can't go.

A Robert Deberry said he could, but his parents were dead against it.

We returned to the meeting. Had a brief discussion of the Congressional Challenge, and a report from Burnell and James. Their principal Tommed out on them, and at the last minute refused to let them have the dance. They have raised about \$25 on their own, however, to send them to Washington.
